DISCIPLINARY ACTIONS TAKEN/LICENSEE ACTIVITY REPORT

Pursuant to compliance with NRS 622.100, this board has taken one disciplinary action against one Residential Facility Administrator, Lorenza Tacotaco, RFA License Number 5971, during the past fiscal quarters - July 1, 2004 through September 30, 2004. A public hearing was conducted on July 27, 2004 for a Complaint where the licensee was found guilty of 2 counts of the Complaint by the Board and was placed on probation for a 2-year period; repayment of legal costs and 40 hours of the mandatory Administrator's Management Training Course and taking and passing the national examination required of all new applicants.

Additionally, enclosed is a copy of the Quarterly Summary and Comparison report of Licensee Activity for the four quarters of fiscal 2003 - 2004.

This board meets quarterly. The last meeting was held on August 10, 2004. The next meeting is scheduled for November 16, 2004.
