RE: DISCIPLINARY ACTIONS TAKEN/LICENSEE ACTIVITY REPORT

Dear Mr. Malkewich

Pursuant to compliance with NRS 622.100, this board has taken one disciplinary action against one Nursing Facility Administrator, Lynn Christensen, NFA License Number 307, during the past fiscal quarters - July 1, 2002 through December 31, 2003. A public hearing was conducted on August 20, 2003 for a Complaint where the licensee was found guilty of 3 counts of the Complaint by the Board and was placed on probation for 2-year period; repayment of legal costs and 16 hours of elder abuse classes through the State's Ombudsman Office. The terms of the settlement have not been finalized to date.

Additionally, enclosed is a copy of the Quarterly Summary and Comparison report of Licensee Activity for the two quarters of fiscal 2003 - 2004.

This board meets quarterly. The last meeting was held on November 19, 2003. The next meeting is scheduled for February 26, 2004
