NEVADA STATE BOARD OF MEDICAL EXAMINERS GRANTS APPLICATIONS FOR LICENSURE OF PHYSICIANS, PHYSICIAN ASSISTANT AND PRACTITIONER OF RESPIRATORY CARE

At its quarterly meeting on September 10 and 11, 2004, the Nevada State Board of Medical Examiners ratified licensure of 246 physicians, 15 physician assistants, and 40 practitioners of respiratory care, and interviewed 19 applicants who were requested to personally appear.

Of the 19 applicants who personally appeared, the Board granted unrestricted licenses to 15 physicians, 1 physician assistant and 1 practitioner of respiratory care, and restricted licenses to 2 physicians to enter residency training at the University of Nevada Medical School residency program in psychiatry.

Since January 1, 2004, the Board has granted 345 physician licenses administratively, that is, to applicants who met all of the statutory and regulatory requirements for licensure. This does not include the 17 applicants who appeared before the Board at the September meeting.

NEVADA STATE BOARD OF MEDICAL EXAMINERS TAKES DISCIPLINARY ACTION AGAINST PHYSICIAN

RICHARD L. WAGNER, M.D.

Richard L. Wagner, M.D., formerly of Las Vegas, Nevada and now practicing in the state of Washington, entered into a stipulation to settle the disciplinary action filed against him by the Board. The Board approved the settlement, and issued an agreed-upon order finding that Dr. Wagner violated NRS 630.3062, for failing to maintain accurate and complete medical records relating to the diagnosis, treatment and care of a patient. The Board ordered a public reprimand to Dr. Wagner and that Dr. Wagner pay all costs of the Board associated with the investigation of the allegations, in the sum of \$1,089.75. The remaining counts of the Complaint were dismissed.
