**Charges:** Unprofessional Conduct;  
Professional Incompetence, lack of ability to safely and skillfully practice medicine, practicing under the influence of a controlled substance.

**Action:** Complaint Filed on August 22, 2001 – Order of Summary Suspension and Order to have Mental/Physical Exam issued by Board.  
October 22, 2001 – Board considered request of Dr. Taylor to amend previous order. Board denied request, Board issued order stipulating approved Sources for mental/physical exam. Board set date of Hearing for January 19, 2002.  
January 19, 2002 – Board and Respondent entered into consent agreement and ordered the following:  
Probation for 7 years.  
Restitution of Prosecution Costs.  
Treatment for underlying mental condition (depression).  
Enrollment in the Impaired physician program (substance abuse).  
Contract with another psychiatrist to treat patients in event of relapse.  
Summary suspension lifted when terms of order have been met.
