## QUARTERLY DISCIPLINARY REPORT TO LEGISLATIVE COUNSEL BUREAU

## FOR

January 1, 2005-March 31, 2005

- James Reilly, DVM 1. February 26, 2005 #RR02-111204-729 The Board filed a complaint on November 12, 2004 for violations of Dr. Reilly's probation. An Accusation was filed and a disciplinary hearing was conducted on February 25, 2005. Dr. Reilly stipulated that he was in violation of his probation and was subject to further disciplinary action. Dr. Reilly was found guilty of the following: 1) Failure to keep records and maintain inventories of controlled substances; 2) Having expired controlled substances in his possession; 3) Allowing unlicensed personnel to perform a euthanasia: 4) Failure to use appropriate methods of a anesthesia, analgesia, and sedation during surgical procedures performed on animals; and 5) Negligence and incompetence. The Board ordered that Dr. Reilly's license to practice veterinary medicine be immediately suspended. The suspension shall remain in full force and effect until Dr. Reilly can demonstrate successful completion of one semester of veterinary surgery and general veterinary medicine. Subsequent to the completion of the educational requirement he must also demonstrate that he has taken and passed the North American Veterinary Licensing Examination or passed both the companion animal and equine species specific examinations.
- 2. Dennis Arn, DVM March 17, 2005 #AS01-072104-318

  A consumer complaint was filed with the Board on July 22, 2004. The complaint was investigated and it was determined that Dr. Arn had violated the provisions of Chapter 638 in that the Licensee's conduct violated NAC 638.045, negligence, a departure from the standard of care in that the Dr. Arn performed an unauthorized procedure on the dog.
- 3. Hany Botros, DVM March 17, 2005 #BS01-083004-1304 A consumer complaint was filed with the Board on August 30, 2004. The complaint was investigated and it was determined that Dr. Botros had violated the provisions of Chapter 638 in that the Licensee's conduct violated NAC 638.045, negligence, a departure from the standard of care in that the Licensee failed to take a scout film prior to the administration of barium in a case where a foreign body was suspected. It was also determined that Dr. Botros failed to maintain adequate medical records.
- 4. Maureen Adams, DVM March 17, 2005 #NA01-081604-1060 A consumer complaint was filed with the Board on August 16, 2004. The complaint was investigated and it was determined that Dr. Adams had violated the provisions of Chapter 638 in that the Licensee's conduct violated NAC 638.045, negligence, a departure from the standard of care in that the Licensee did not repair the tears in the mesentery and did not inform the client that the animal could require monitoring after release.
