A consumer complaint was filed with the Board on January 3, 2006. The complaint was investigated and it was determined that Dr. Kempf had violated the provisions of Chapter 638 in that the Licensee's conduct violated NAC 638.045 (2), negligence, a departure from the standard of practice of veterinary medicine, in that the Licensee failed to use an appropriate technique of ligation during a c-section and ovariohysterectomy. The Board Order stated that: 1) The Licensee shall pay investigative costs to the Board in the amount of \$250.00; and 2) Take an additional three hours of continuing education in reproduction which must include surgery and two hours of continuing education in critical care.

A consumer complaint was filed with the Board on August 1, 2005. The complaint was investigated and it was determined that Dr. Hittenmiller had violated the provisions of Chapter 638 in that the Licensee's conduct violated NAC 638.053, in that the Licensee allowed unlicensed personnel who were owners of the animal to administer a controlled substance and closed a wound with staples. The Board Order stated that: 1) The Licensee shall pay investigative costs to the Board in the amount of \$250.00; 2) The Licensee shall take and pass the Nevada State Jurisprudence examination; 3) The veterinary facility shall be subject to random inspections at staff's discretion and the Licensee's expense; and 4) Will not allow any of his employees to perform animal health tasks for which licensure is required as a veterinary technician.

The Board Order stated that: 1) The Licensee shall pay investigative costs to the Board in the amount of \$250.00; and 2) Take an additional three hours of continuing education in critical care.
