PROPOSED REGULATION OF THE BOARD OF WILDLIFE COMMISSIONERS

NOTICE OF INTENT TO ACT UPON A REGULATION Notice of Hearing for The Amendment of Regulations of The Nevada Board of Wildlife Commissioners

The Board of Wildlife Commissioners will hold a public hearing at 8:30 a.m. on July 24, 1999, at the Great Basin College, 1500 College Parkway, Greenhaw Technical Building, Room 130, Elko, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulation CGR 277 pertaining to Chapter 503 of the Nevada Administrative Code.

- 1. The need for and purpose of the proposed regulation: The hunting public has reported increased use of various types of aircraft, particularly those capable of low-speed and low-altitude, allegedly for the purpose of locating and hunting trophy-class big game animals, during big game seasons. Such activity has the potential to create conflict between hunters who hunt in a traditional manner and those using enhanced methods of locating wildlife; this also raises the issue of unethical methods of hunting which may cast a negative light on hunters, detracting from the concept of fair chase. The purpose is to prohibit the hunting of wildlife in a management unit, for a period of 96 hours, after using or being aided by the use any aircraft over the management unit.

3A. The estimated economic effect of the regulation on the business which it is to regulate:

- (a) Adverse effect A few but unknown number of guides may be impacted due to the potential loss of "trophy" fees from their clients who harvesting a trophy class animal with the aid or assistance of aircraft. The practice of using aircraft, particularly low-speed, low-altitude versions, by guides in Nevada appears to be at a low level at present though complaints appear to be increasing over the past two years. The potential is there to increase since most neighboring states have adopted similar prohibitions and some guides from those states also guide here.

<u>Commission General Regulation Number 277:</u> Proposes to amend Chapter 503 of the Nevada Administrative Code by prohibiting hunting for the period of 96 hours after flying over a big game management unit.

<u>Commission General Regulation Number 279:</u> Proposes to amend NAC 502.380 by deleting the reference to "tundra" as it applies to the hunting of swan; and establishes a provision for the mandatory inspection of a harvested swan.

<u>Commission General Regulation Number 280:</u> Proposes to amend NAC 504.340 by correcting the names of national wildlife refuges and other federally administered properties; deleting information which is outdated.

PROPOSED REGULATION OF THE BOARD OF WILDLIFE COMMISSIONERS

COMMISSION GENERAL REGULATION 277

Authority: NRS 501.105, 501.181

Notice of Intent: June, 1999 Workshop Date: July 24, 1999 Commission Approval: , 1999

EXPLANATION: This regulation proposes to amend Chapter 503 of the Nevada Administrative Code by prohibiting hunting for a set period of time after using aircraft over a management unit.

NOTE: Matter in *italics* is new; matter within brackets \vdash is to be omitted.

Section 1. Chapter 503 of NAC is hereby amended by adding thereto a new section to read as follows:

- 1. As used in this section:
- a. "Aircraft" means any motor-driven device or contrivance which is used for flight in air.
- b. "Management unit" means that portion of a management area for big game mammals as described in NAC 504.210.
- 2. Except as provided in subsection 4, it is prohibited for any person to hunt or take any wildlife in a management unit for at least 96 hours after having:
 - a. flown in any aircraft over the management unit, or
 - b. been aided by the use of any aircraft which was flown over the management unit.
- 3. Except as provided in subsection 4, it is prohibited for any person to assist, in any manner, another person in the hunting of any wildlife in a management unit for at least 96 hours after having:
 - a. flown in any aircraft over the management unit, or

- b. been aided by the use of any aircraft which was flown over the management unit.
- 4. The provisions of this section do not apply to a person flying on a regularly scheduled commercial airliner, including a commuter airline capable of carrying 10 passengers, which departs and lands at an airport which has been established by a department or agency of the federal or state government or by a county or municipal government.
