Section 1. NAC 704.450 is hereby amended to read as follows:

704.450 Adoption of federal electrical code.

The following statement is submitted for adopted amendments to Nevada Administrative Code ("NAC") 704.

The regulation in Public Utilities Commission of Nevada ("Commission")Docket No. 98-9020 was published in the Henderson Home News on December 24, 1998, the Las Vegas Review Journal on December 10, 1998, and the Nevada Appeal on December 6, 1998. Additionally, the notice was mailed to city and county clerks, the Attorney General's Bureau of Consumer Protection - Utility Consumer's Advocate, county libraries, and all persons who requested inclusion on the Commission's service list. There was no public response except from affected businesses which is discussed in #3 below. (e) Submitted to the agency written comments: Written comments were submitted to the Commission in writing by the Regulatory Operations Staff ("Staff") of the Commission and Sierra Pacific Power Company ("Sierra").

3. A description of how comment was solicited from affected businesses, a summary of their response, and an explanation how other interested persons may obtain a copy of the summary.

Comments were solicited from affected businesses by the notices in the newspapers, as outlined in #1above, and by direct mail to interested persons subscribing to the Commission's mailing list. Sierra supported the regulation as proposed, although presented information of an updated mailing address of the Institute of Electrical and Electronics Engineers, INC. ("IEEE"). Sierra, therefore, proposed that the regulation be revised to reflect such updated information. 4. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

The only changes to the proposed regulation were to the address of the IEEE and to the cost of obtaining a copy of the National Electrical Safety Code ("NESC"), which were both discussed and agreed upon at the workshop and hearing. The regulation was adopted by the Commission at a regularly scheduled agenda meeting held on January 29, 1999.

- 5. The estimated economic effect of the adopted regulation on the business which it is to regulate and on the public. These must be stated separately, and each case must include:

 - (2) The proposed regulation is expected to have a negligible effect on the public, both immediate and long-term, since, according to Staff's comments, Sierra's and Nevada Power Company's ("NPC") current construction, operations, and maintenance standards already comply with the most recent version of the NESC.

There is no additional cost to the agency for enforcement of this regulation.

Although this regulation increase the fee to obtain a copy of the NESC, the IEEE rather than the Commission collects this fees and, thus, there is no amount of money that the Commission expects to collect.
