NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Workshop and Hearing for the Adoption, Amendment or Repeal of Regulations Of The State Contractors' Board

The State of Nevada Contractors' Board ("Board") will hold a workshop and public hearing at the Board's Reno Office located at 9670 Gateway Drive, Reno, Nevada 89521 on Friday, March 28, 2003 and videoconferenced to the Board's Henderson Office located at 2310 Corporate Circle, Suite 200, Henderson, Nevada 89074. The workshop will begin at 10:00 a.m. and the hearing will commence immediately following the workshop. The purpose of the workshop and hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of regulations that pertain to Chapter 624 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.060 and 233B.0603:

1. The need for and purpose of the proposed regulation or amendment.

The purpose of the proposed regulation is to amend Chapter 624 of the Nevada Administrative Code to add a subclassification to solar contracting for the installation of photovoltaics of and to add a fee for reviewing an application that is filed with the Board pursuant to an entity conversion.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed or a description of the subjects and issues involved.

The proposed regulation establishes a subclassification to solar contracting for the installation of photovoltaics and adds a fee for reviewing an application filed with the Board pursuant to an entity conversion. A copy of the proposed regulation may be obtained by writing to the Board's offices at 9670 Gateway Drive, Reno, Nevada 89521.

3. The estimated economic effect of this proposed regulation on the business which it is to regulate and on the public.

(a) Adverse and beneficial effects.

There should be minimal economic effect on either the construction business or the public.

(b) Both immediate and long-term effects.

There should be minimal immediate or long-term effects.

- **4.** The estimated cost to the Agency for enforcement of the proposed regulation. There will be minimal cost to the agency.

If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Board may proceed immediately to act upon any written submissions.

In all counties in which an office of the Board is not maintained, a copy of this notice and the text of the proposed regulation will also be available for public inspection and copying at the main public library during business hours. This notice and the text of the proposed regulation will be available in the State of Nevada Register of Administrative Regulations which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the Board, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

AUTHORITY: NRS 624.100, NRS 624.241, and NRS 624.281

NAC 624.540 Classification C-37: Solar contracting; subclassifications.

- 1. The board will grant to qualified applicants a license in the specialty of solar contracting. The board designates such a license as a "classification C-37" license. A person who holds a classification C-37 license may design, fabricate and install systems for the collection of solar energy to *provide electricity, and* heat and cool water, air and chemicals.
- 2. The subclassifications of the classification C-37 license and the work authorized for persons licensed in the respective subclassifications are:
- (a) WATER HEATING (subclassification C-37a): The installation of systems for the collection of solar energy to heat water for potable uses, but not the installation of pipes or fixtures other than water heaters and storage tanks designed for the use of water so heated.
- (b) SPACE HEATING (subclassification C-37b): The installation of systems for the collection of solar energy to heat water or air which is in turn used to heat structures which house persons, animals or inanimate objects including storage, piping and heat exchangers, but excluding equipment for pools.
- (c) AIR CONDITIONING (subclassification C-37c): The installation of the collectors, piping, storage and other equipment used in the conversion of solar energy to energy used for the control of air temperatures.
- (d) HEATING OF POOLS (subclassification C-37d): The installation of the collectors, piping and heat exchangers used to heat swimming pools and spas with solar energy, but not the plumbing of swimming pools or the installation of their equipment.
- (e) PHOTOVOLTAICS: The installation of photovoltaic cells, batteries, and invertors for the conversion of sunlight into electric power, but not the installation, alteration or repair of electrical wires beyond the service panel.
