# PROPOSED REGULATION OF THE COMMISSIONER OF INSURANCE

## NOTICE OF WORKSHOPS TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The Department of Business and Industry, Division of Insurance (Division), is proposing new regulations pertaining to rate service organizations and lost cost adoption; use of chargeable accidents and proposed repeal of Nevada Administrative Code (NAC) 690B.230; and repeal of certain regulations concerning company rate and form filing requirements. A workshop has been set for **9:00 a.m., on May 25, 2006**, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested parties may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Manufactured Housing Division Conference Room, 2<sup>nd</sup> Floor, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics addressed in the proposed regulations:

- 1. Rate Service Organizations and Loss Cost Adoption. The proposed amendments to Chapter 686B of the NAC provide that rate service organizations shall be examined at intervals not less than 5 years. Also clarified is that insurers underwriting policies of industrial insurance (workers' compensation) must use the current approved loss costs filed by the advisory organization. Some insurers may have been confused by the language in NAC 686B.460 which was never intended to apply to policies of industrial insurance.
- 2. <u>Use of Chargeable Accidents and Proposed Repeal of NAC 690B.230</u>. The proposed amendment to Chapter 687B of the NAC clarifies that insurers cannot use non-chargeable accidents in rating, cancellation or non-renewal of a private passenger auto policy. Also, proposed repeal of NAC 690B.230.
- 3. Repeal of Certain Publications Concerning Company Rate and Form Filing Requirements. Repeal of NAC 680B.060 which allows an insurer to submit one rate and form filing on behalf of a group of insurers rather than submitting one rate and form filing for each insurer. Repeal of NAC 680B.080 which requires surplus lines carriers to pay certain filing fees to the Division.

## Notice of Hearing for the Adoption of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance (Division), will hold a public hearing at **9:00 a.m., on May 25, 2006,** immediately following a public workshop, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested persons may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Manufactured Housing Division Conference Room, 2<sup>nd</sup> Floor, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of:

## PROPOSED REGULATION CONCERNING RATE SERVICE ORGANIZATIONS AND LOSS COST ADOPTION

1. A statement of the need for and purpose of the proposed regulation:

These regulations establish the intervals at which rate service organizations shall be examined pursuant to NRS 686B.170. Also established are procedures for adoption of loss costs for policies of industrial insurance.

2. Either the terms or substance of the proposed regulation or a description of the subjects and issues involved:

These regulations provide that rate service organizations shall be examined at intervals not less than 5 years. Also clarified is that insurers underwriting policies of industrial insurance (workers' compensation) must use the current approved loss costs filed by the advisory organization. Some insurers may have been confused by the language in NAC 686B.460 which was never intended to apply to policies of industrial insurance.

- 3. Estimated economic effect of the regulation:
  - (I) Both adverse and beneficial effects: These changes are not anticipated to have any adverse or beneficial economic impact on the business which it regulates or the public, either immediately or in the long-term.
  - (II) Both immediate and long-term effects: See (I) above.
- 4. A statement identifying the methods used by the agency in determining the impact on a small business prepared pursuant to subsection 3 of NRS 233B.0608:

Rate service organizations are not small businesses. As a result, these regulations will have no impact on small businesses.

5. The estimated cost to the agency for enforcement of the proposed regulation:

The cost to examine rate service organizations is billed back to the organization. There is no cost to the State. The Division uses contract examiners.

6. A description of any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary; if the regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency:

# PROPOSED REGULATION OF THE COMMISSIONER OF INSURANCE

## PROPOSED REGULATION CONCERNING RATE SERVICE ORGANIZATIONS AND LOSS COST ADOPTION

AUTHORITY: NRS 679B.130, NRS 686B.070, NRS 686B.100, NRS 686B.170, AND NRS 686B.1775

REGULATIONS relating to the examination of rate service organizations and adoption of loss costs by insurers.

- **Section 1.** Chapter 686B of NAC is hereby amended by adding thereto the provisions set forth as sections 2 and 3 of this regulation.
- Sec. 2. For the purpose of informing himself about any matter related to the enforcement of the insurance laws, the Commissioner shall, as often as he deems advisable, examine the affairs and conditions of each rate service organization in accordance with NRS 686B.170. He shall so examine each licensed rate service organization not less frequently than every 5 years.
- Sec. 3. Each filing of final rates or loss cost multipliers for policies of industrial insurance made pursuant to NRS 686B.1775, at a minimum, shall include the following:
  - 1. The appropriate Expense Worksheet prescribed by the Commissioner:
  - (a) Expense Worksheet A if an expense constant (a premium charged to each policy of industrial insurance regardless of the size of the policy) applies, or
    - (b) Expense Worksheet B if there is no expense constant.
- 2. Reference to premium discount table(s) applicable and the rules for applying such discount.
  - 3. An insurer may continue to use the loss cost multipliers so filed until:

- (a) the loss cost multipliers are disapproved, or
- (b) the insurer makes a filing to replace the loss cost multipliers previously filed.
- 4. An insurer must utilize the current loss cost filed by the advisory organization in accordance with the anniversary rating date rule in the Basic Manual unless the Commissioner has explicitly approved otherwise.
- **Sec. 4.** NAC 686B.445 is hereby amended to read as follows:
- 1. A filing by an insurer that refers to a reference filing of prospective loss costs made by a rate service organization must include, in the following order, a reference filing adoption form and a summary of supporting information.
- [2. The reference filing adoption form is available from the Department of Business and Industry, Division of Insurance, 1665 Hot Springs Road, Carson City, Nevada 89710.]
- **Sec. 5.** NAC 686B.460 is hereby amended to read as follows:
- 1. Except as otherwise provided in subsection 2, NAC 686B.400 to 686B.460, inclusive, do not require a rate service organization or its participating insurers to refile a rate *or loss cost* previously approved by the Commissioner.
- A participating insurer or a rate service organization may continue to use any rate, *loss* cost or deviation filed and approved for its use until:
  - (a) The rate[s], loss cost or deviation is [are] disapproved; or
  - (b) The insurer makes its own filing to change its rate by making an independent filing or by filing a reference filing adoption form that adopts the prospective *rates or* loss costs of a rate service organization or an adjustment to the prospective *rates or* loss costs by the insurer.
