PROPOSED REGULATION OF THE

BOARD OF WILDLIFE COMMISSIONERS

LCB File No. R126-06

June 23, 2006

EXPLANATION - Matter in *italics* is new; matter in brackets [omitted material] is material to be omitted.

AUTHORITY: §1, NRS 501.105, 501.181 and 501.1818; §§2 and 3, NRS 501.105, 501.181 and 502.160; §§4 and 5, NRS 501.105, 501.119, 501.181 and 502.160; §§6 and 7, NRS 501.105, 501.181, 502.160 and 502.175.

A REGULATION relating to hunting; requiring permits to hunt swans; revising requirements for tag validations; revising provisions for bonus points; and providing other matters properly relating thereto.

Section 1. NAC 501.200 is hereby amended to read as follows:

501.200 1. A person who is convicted of a wildlife violation will be assessed demerit points pursuant to the following schedule:

- 2. A person who is convicted of committing a wildlife violation that does not appear in the schedule set forth in subsection 1 will be assessed 3 demerit points.
- 3. A person who is convicted of committing a wildlife violation within 60 months after a conviction for the same violation will be assessed double the amount of demerit points listed in the schedule set forth in subsection 1.
- 4. A person who is convicted of committing any four wildlife violations within a 60-month period will be assessed an extra 12 demerit points.
 - **Sec. 2.** NAC 502.380 is hereby amended to read as follows:
- 502.380 1. A [tag] permit is required to hunt swan. The fee for the [tag is \$10.] permit is \$5. A person [may obtain a form to] must apply for the [tag from a license agent or an office of]

permit on a form provided by the Department. The form must be completed in accordance with the instructions thereon. Award of the **[tags]** *permits* by the Department will be based on a drawing held after the date specified on the form.

- 2. Each person, while hunting swan, shall carry on his person a:
- (a) Hunting license issued by the Department, or a nonresident permit to hunt upland game and waterfowl;
 - (b) Swan [tag] hunt permit issued by the Department;
- (c) State duck stamp, or any other such documentation as the Department provides as proof that he has paid to the Department the fee for the state duck stamp; and
- (d) Federal migratory bird hunting stamp, or any other such documentation as the Federal Government provides as proof that he has paid to the Federal Government the fee for the federal migratory bird hunting stamp.
 - 3. When a hunter has killed a swan and taken it into his possession, he shall:
- (a) Immediately punch and attach the [tag] swan hunt permit in the manner required by NAC 502.390 and 502.400; and
- (b) Except as otherwise provided by an order or regulation of the Commission, not later than 5 days after he has killed and taken the swan into his possession, submit the head and neck of the swan to a representative of the Department for inspection at a location designated by the Department. The Department shall provide a list of the locations upon the issuance of the [tag.] swan hunt permit.
- 4. A person shall not use or possess a [tag] swan hunt permit issued to any other person, or transfer or give a [tag] swan hunt permit issued to him to any other person.
 - **Sec. 3.** NAC 502.385 is hereby amended to read as follows:

- 502.385 1. The tag *or permit* must be carried by the owner at all times while he is hunting or trapping or while he is fishing for wildlife for which a tag *or permit* is required. It is unlawful for any person to use or possess a tag *or permit* issued to any other person or to transfer or give a tag *or permit* issued to him to any other person.
- 2. It is unlawful for a person to use any tag *or permit* in a management area or unit for which it is not intended or to use a tag *or permit* at any time other than at the time intended.
- 3. After it has been issued, a tag *or permit* may not be exchanged or a refund made except in accordance with the policies and regulations of the Commission.
 - **Sec. 4.** NAC 502.390 is hereby amended to read as follows:
- 502.390 When a person reaches any wildlife which he has killed, he *immediately* must validate his tag *or permit* by cleanly punching out the spaces necessary to properly identify the physical description of the animal including its sex and antler points, where appropriate, and the day and month of the kill.
 - **Sec. 5.** NAC 502.400 is hereby amended to read as follows:
- 502.400 1. Except as otherwise provided in subsection 2, the owner of a tag *or permit* must firmly attach it to the carcass of an animal killed by him, at or before the time he first reaches his means of *motorized* transportation, *lodging* or camp. *If multiple trips are necessary* to remove the meat or carcass of an animal from the location where it was killed, the validated tag or permit must remain with the first portion of the meat or carcass removed from the location of the kill. Once the entire carcass or all of the meat has been removed from the location where the animal was killed, [The] the tag or permit must remain with the major portion of the meat until it is consumed.

- 2. If the animal killed is a mountain lion or fur-bearing mammal for which a tag *or permit* is required, the owner of the tag *or permit* must firmly attach it to the hide or pelt of the animal. The tag *or permit* must remain attached to the hide while it is transported and until it is processed.
 - **Sec. 6.** NAC 502.4187 is hereby amended to read as follows:
- 502.4187 1. Except as otherwise provided in NAC 502.416 to 502.4225, inclusive, an applicant to obtain a tag for a season who is unsuccessful, or an applicant for a bonus point who does not wish to obtain a tag and is applying for the sole purpose of earning a bonus point, must be awarded a bonus point for:
 - (a) The hunt number of the species for which he applied if he applied for a:
 - (1) [Tag to hunt swan;
- ———(2)] Tag to hunt wild turkey;
 - [(3)] (2) Depredation hunt tag; or
 - [(4)] (3) Bonus point for a tag described in subparagraph [(1), (2) or (3);] (1) or (2); or
- (b) The category of the species for which he applied if he applied for a tag to hunt deer, elk, mountain goat, antelope or bighorn sheep, or for a bonus point for such a tag.
- Regardless of the number of applications to obtain a tag or bonus point for a season submitted by a person, the Department shall not award him more than one bonus point per season for each species or category of a species for which the person applied.
- 2. Except as otherwise provided in subsection 3, the bonus points awarded to a person accumulate until he is successful in drawing a tag for a season for that species or category of a species or he fails to apply for a season for 2 consecutive calendar years during which that type of hunt for a season is open. If an applicant is successful in drawing a tag for a season for a

species or category of a species or fails to apply for a season for 2 consecutive calendar years during which that type of hunt for a season is open, he loses all of his bonus points for that species or category of a species.

- 3. A person may not use any bonus points awarded to him for being unsuccessful in a junior hunt to apply for a drawing for a tag for any other type of hunt after the person is no longer eligible to participate in a junior hunt.
- 4. If an applicant requests and receives a refund for the value of his hunting license, the Department shall not award him a bonus point for any species or category of species applied for during the period that the applicant possessed the hunting license.
 - **Sec. 7.** NAC 502.4188 is hereby amended to read as follows:
- 502.4188 1. Except as otherwise provided in subsection 2, any bonus points awarded by the Department pursuant to the bonus point program must be awarded in one of the following categories of species:
 - (a) Antlered mule deer;
 - (b) Antlerless mule deer;
 - (c) Mule deer, either antlered or antlerless;
 - (d) Antlered Rocky Mountain elk;
 - (e) Antlerless Rocky Mountain elk;
 - (f) Rocky Mountain elk, either antlered or antlerless;
 - (g) Spike Rocky Mountain elk;
 - (h) Pronghorn antelope whose horns are longer than their ears;
 - (i) Pronghorn antelope whose horns are shorter than their ears;
 - (j) Rams, from one of the following subspecies:

- (1) Nelson bighorn sheep;
- (2) California bighorn sheep; or
- (3) Rocky Mountain bighorn sheep; or
- (k) Mountain goats.
- 2. Bonus points awarded by the Department pursuant to the bonus point program for wild turkey [, swan] and depredation hunts must be awarded by hunt number.
