# PROPOSED TEMPORARY REGULATION OF THE NEVADA STATE BOARD OF ATHLETIC TRAINERS

## NOTICE OF HEARING FOR THE ADOPTION OF REGULATIONS OF THE NEVADA INTERSCHOLASTIC ACTIVITIES ASSOCIATION

The Nevada Interscholastic Activities Association ("NIAA") will hold a public hearing starting at 10:30 a.m. on the 7th day of March, 2007 and at 9:30 a.m. on the 8<sup>th</sup> day of March 2007, at Palo Verde High School, 333 Pavilion Center Drive, Las Vegas, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of Regulations that pertain to Chapter 386 of the Nevada Administrative Code.

The following is provided pursuant to the requirements of NRS 233B.0603:

- 1. The adoption of these Regulations are needed for purposes of the governance of high school athletics and activities throughout the State of Nevada which are governed by the NIAA.
  - 2. The Regulation changes will address the following:
  - (a) NAC 386.871 Lifetime Pass: Prerequisites to issuance; use
  - (b) NAC 386.693 Approval by Association of competition when each member of all-star team is eligible to participate in sanctioned sport.
  - (c) NAC 386.696 Restrictions on participation in out-of-season activities relating to sanctioned sports.
  - (d) NAC 386.851 Appeal of certain determinations that impose hardship on pupil.
- 3(a). The economic effect of the Regulation on high school athletics will be minimal.
- (b). The immediate and long term effects of this Regulation will be to provide a better source of information to the public regarding the governance of high school athletics and activities, including high school athletes, parents, coaches and officials all of whom are governed by the NIAA.
- 4. The estimated cost to the NIAA for purposes of enforcement of the proposed Regulation are minimal.

- 5. This Regulation does not overlap or duplicate any regulations of other state or local governmental agencies.
  - 6. The adoption of this Regulation is not required pursuant to federal law.
- 7. The adoption of this Regulation does not include any provisions which are more stringent then any federal regulation. *See*, paragraph 6, above.
- 8. The adoption of this Regulation does not establish any new fee or increases to existing fees associated with the governance of the NIAA.

Persons wishing to comment upon the proposed action of the NIAA may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to Eddie Bonine, Executive Director, Nevada Interscholastic Activities Association, One East Liberty Street, Suite 505, Reno, Nevada 89501. Written submissions must be received by the NIAA on or before March 2, 2007. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the NIAA may proceed immediately to act upon any written submissions.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within thirty (30) days thereafter, will issue a concise statement of the principal reasons for and against it's adoption and incorporate therein it's reason for overruling the consideration urged against it's adoption.

## Adoption of Nevada Administrative Code 640B PROPOSED CHANGES IN FEES, <u>Attachment</u>

As required by NRS 640B.410 fees established by the Board are as follows:

- 1. An applicant shall pay the following fees:
  - a. Initial application for licenses will be \$300.00 for a period of one licensing year or portion there of.
  - b. Reinstatement of an expired license: \$300.00
- 2. A licensee shall pay the following fees:
  - a. Change of name on a license: \$25.00
  - b. Duplicate of a lost license: \$25.00
  - c. Failure to notify board of personal address change within 30 days of change: \$75.00
  - d. Failure to notify board of business address change within 30 days of change: \$75.00
- 3. License renewals
  - a. Annual renewal of a license occurs June 30 for a fee of \$150.00.
  - b. A late fee for annual renewals beyond the June 30 deadline is \$75.00.
  - c. If renewal is not made the license will expire.
- 4. General Fees
  - a. The fee for a list of business addresses of licensees is \$25.00
  - b. The fee for list of business addresses of licensees on mailing labels is \$100.00
  - c. The fee for a dishonored check is \$25.00
- 5. General Fee information
  - a. Fees shall not be refundable.
  - b. Necessary fees shall accompany applications or appropriate documentation.
