## PROPOSED TEMPORARY REGULATION OF THE COMMISSIONER OF INSURANCE

## NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED TEMPORARY REGULATIONS

The State of Nevada Department of Business and Industry, Division of Insurance (Division), (775) 687-4270, is proposing the adoption of temporary regulations pertaining to chapters 687B and 690B of the Nevada Administrative Code (NAC). A workshop has been set for **9:00 a.m., on March 3, 2009**, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested parties may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Real Estate Division Conference Room, 2<sup>nd</sup> Floor, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed temporary regulations.<sup>1</sup>

<u>Long-Term Care Producer Compensation</u>. The proposed temporary regulation will amend chapter 687B of the NAC and provide a correction to Sec. 7 of regulation R121-07 concerning producer compensation for long-term care insurance.

<u>Automobile Identification Card</u>. The proposed temporary regulation will amend NAC 690B.030 to provide for the issuance, by a producer of insurance, of a permanent automobile identification card constituting evidence of insurance.

#### NOTICE OF INTENT TO ACT UPON TEMPORARY REGULATION

## Notice of Hearing for the Adoption of Temporary Regulations of the Department of Business and Industry, Division of Insurance<sup>2</sup>

The State of Nevada Department of Business and Industry, Division of Insurance (Division), will hold a public hearing at 9:00 a.m., on March 10, 2009, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested persons may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 E. Sahara Avenue, Real Estate Division Conference Room, 2<sup>nd</sup> Floor, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of the temporary regulation that pertains to chapter 690B of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed temporary regulation or amendment.

The amendment of NAC 690B.030 clarifies that a producer of insurance may issue a permanent automobile insurance identification card constituting evidence of insurance on behalf of an insurer and eliminates the confusing and contradictory language in subsection 3.

2. Either the terms or substance of the regulation to be adopted, amended, or repealed, or a description of the subjects and issues involved.

The amendment of NAC 690B.030 eliminates contradictory language regarding a producer's ability to issue a permanent automobile insurance identification card on behalf of an insurer by deleting subsection 3. Additionally, by adding new language under subsection 1(c), the amendment clarifies that a producer may issue a permanent automobile insurance identification card if the producer has a written contractual agreement with the insurer to issue such an identification card.

3. The estimated economic effect of the regulation on the business that it is to regulate and on the public.

## **Business Regulated**

Adverse:

Beneficial: The amendment allows the producer to issue a permanent automobile insurance identification card on behalf of the insurance company when coverage is bound or changes are made to a policy. Immediate effects are to eliminate any confusion about whether a producer can issue a permanent evidence of automobile insurance identification card on behalf of an insurer. Both short-term and long-term effects include: 1) reduces the expense and redundancy of issuing a temporary automobile insurance identification card in

addition to a permanent automobile insurance identification card; and 2) allows a producer to provide an extension of service on behalf of the insurer by providing immediate evidence of liability insurance to the insured.

### Public

Adverse: None

Beneficial: Immediate and long term effects include: 1) allows a producer to provide an extension of service on behalf of the insurer by providing immediate evidence of liability insurance to the insured; and 2) enhances the producer/consumer relationship through enhanced service.

4. The estimated cost to the agency for the enforcement of the proposed temporary regulation.

Enforcement of this regulation would be through regularly scheduled market conduct examinations paid for by the company. The examination would determine whether the relevant producers are properly appointed by the insurer or whether proper contracts are in place between the producer and insurer allowing the producer to issue permanent automobile insurance identification cards on its behalf. Therefore, there would be no additional expense to the Division to enforce the temporary regulation.

5. A description of and citation to any regulations of other state or local governmental agencies that the proposed regulation overlaps or duplicates, and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.

This does not apply to a public body subject to the Open Meeting Law.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption, and incorporate therein its reason for overruling the consideration urged against its adoption.

## Chapter 690B of NAC

# PROPOSED TEMPORARY REGULATION OF THE COMMISSIONER OF INSURANCE

EXPLANATION – Matter in *italics* is new; matter in brackets formitted material is material to be omitted.

**AUTHORITY: NRS 679B.130** 

A TEMPORARY REGULATION relating to the issuance of a permanent card constituting evidence of insurance.

**Section 1.** Chapter 690B.030 of NAC is hereby amended as follows:

1. A permanent card constituting evidence of insurance must be issued by an insurer who provides liability insurance coverage for a motor vehicle in the minimum amounts required by NRS 485.105 and 485.185, except that the insurer may permit [its duly appointed agent in Nevada] *a producer* to issue a permanent card if:

- (a) The [agent] producer has authority to issue policies; and
- (b) The Division has been notified in writing by the company that the [agent] producer has such authority [...]; or
- (c) The producer has a written contractual agreement with the insurer to issue a permanent card on their behalf.
  - 2. A permanent card:
  - (a) May not be effective for more than 1 year beginning on the effective date of the policy.
  - (b) Must be issued:
- (1) Within 60 days after the effective date of an insurance policy or the issuance of a binder; and

- (2) With each renewal of the policy.
- [3. An agent or broker may not print a permanent card or cause a permanent card to be printed by any person.]

Sec. 2. Effective date. Pursuant to NRS 233B.063, as a temporary regulation, sections 1 to 2 become effective as of the date filed with the Secretary of State and remain in effect until November 1, 2009, unless otherwise replaced or repealed prior to that date.
