PROPOSED REGULATION OF THE ADMINISTRATOR OF THE DIVISION OF STATE PARKS OF THE STATE DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES

NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Amendment of Regulations for the Nevada Division of State Parks

The Nevada Division of State Parks will hold a public hearing on Wednesday October 12, 2011, from 3:00-5:00pm, in Carson City at the Richard Bryan Building, 901 S. Stewart Street, 2nd floor, Tahoe Hearing room. The public hearing will be videoconference from the State Parks Southern Region office at 4747 Vegas Drive, in Las Vegas.

The following information is provided pursuant to the requirements of NRS 233B.0603:

- 1. The purpose of the public hearing is to solicit comments from interested persons on Nevada Administrative Code (NAC) 407.105, Possession or Use of Weapons in parks.
- 2. The Division proposes to amend NAC Chapter 407 section 105 to remove prohibitions against possession of a firearm in State Parks and to clarify prohibitions on firearms discharge to specifically recognize the right to self defense.
- 3. The estimated economic effect of these regulations on the business which it is to regulate and on the public.
 - a. Adverse and beneficial effects: No appreciable effects.
 - b. Immediate and long term effects: No immediate or long term effects are perceived

on the public or businesses.

- 4. These changes in the regulation do not impact on small businesses.
- 5. There is no cost to State Parks for the enforcement of the proposed regulation.
- 6. These changes in regulations do not overlap or duplicate any other federal, state or local regulations.
- 7. This regulation is not required pursuant to federal law, a citation and description of the federal law.
- 8. This regulation does not include provisions, which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions.

9. The proposed regulation does not establish a new fee or increases an existing fee.

Persons wishing to comment upon the proposed action of the Division of State Parks may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to Nevada State Parks, 901 S. Stewart Street, Suite 5005, Carson City, NV 89701-5248 or emailed to acloutie@parks.nv.gov. Written submission must be received by the Nevada State Parks on or before October 12. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Parks may proceed immediately to act upon any written submissions.
