



Asm District 40 Estimated Population



#### **Age Distribution**










#### **Educational Attainment for Population 25 Years and Over**









#### **Household Income**










#### **Poverty Level by Education**





#### **Health Insurance by Age**



#### **Health Insurance by Employment Status**






