Biennial Report on the Southern Nevada Enterprise Community (SNEC)

January 30, 2025



Activities of the SNEC Board in 2024:

During the calendar year of 2024, the SNEC Board began its collaboration with both the Las Vegas Global Economic Alliance (LVGEA) and the Regional Transportation Commission of Southern Nevada (RTC) in the creation of the next iteration of the Comprehensive Economic Development Strategy (CEDS). These entities collaborated on a Planning and Local Technical Assistance grant application to the US Economic Development Administration (EDA) for funds to support the contractors that will handle the creation of a CEDS plan. An equity-woven CEDS plan will allow Southern Nevada and SNEC to more competitively apply and receive federal funds to support our work.

The Board held four (4) meetings, which included presentations and discussion from the following organizations regarding their activities affecting the SNEC-designated census tracts:

- Nevada Department of Health and Human Services, regarding Project 354 Workforce Development and Outreach
- City of Las Vegas on workforce efforts by the Youth Development & Social Initiatives department

- City of North Las Vegas, regarding equity in distressed communities in North Las Vegas
- Las Vegas Global Economic Alliance, regarding updates for the CEDS and the Planning and Local Technical Assistance grant application to the EDA
- Nevada Partners, Inc., regarding the Clark County School District-funded "Learning Acceleration and Wraparound Support Youth Education Program"
