SUBJECT: **NRS 391.155 - Consultant Reports**

---

*Nevada Revised Statutes* (NRS) 391.155 requires reporting of the use of consultants by school districts in the State of Nevada. The statute requires school districts to submit to the Interim Finance Committee, at least once every six months, a report concerning each consultant employed by the district.

The next semiannual report will be for the period beginning **July 1, 2022, through December 31, 2022**. The attached form should be utilized for reporting the information required in NRS 391.155. In addition, be advised that the Legal Division of the Legislative Counsel Bureau has interpreted the term "consultant" to include any person or entity that renders professional services or advice.
