BRIEFING ON TRANSPORTATION TOPICS

Troy L. Dillard is the Interim Director of the Department of Motor Vehicles (DMV) and has held this position since November 2012. He served as the Deputy Director of the DMV for the previous two years and began his tenure with the Department as the Administrator of the Division of Compliance Enforcement in 2004. Mr. Dillard has a bachelor's degree in criminal justice from the University of Nevada, Reno, and holds a management certificate from the Nevada Peace Officers' Standards and Training Commission. He serves on various boards and commissions relating to transportation and public safety.

Nancy Wojcik is the Administrator of the Division of Field Services of the DMV and has held her current position since October 2009. She is responsible for 18 Field Service offices throughout the State and has over 650 employees in her Division. Mrs. Wojcik has been employed by the DMV for over 25 years and is a graduate of the Certified Public Managers Program.

Deborah Cook is the Administrator of the Administrative Services Division of the DMV and has held her current position since June 2009. In addition to working for the DMV for over 21 years, Ms. Cook has worked for the Administrative Office of the Courts, the Department of Administration, the Division of Welfare and Supportive Services, and the Supreme Court. She has an associate of applied science accounting degree from Western Nevada Community College in Carson City, Nevada, and is a graduate of the Certified Public Managers Program.

Rudy Malfabon is the Director of the Nevada Department of Transportation (NDOT), where he has worked for more than 25 years. Nearly half of Mr. Malfabon's NDOT career was spent in Carson City, where he held the titles of Assistant and Chief Construction Engineer. He left NDOT to become the State Construction Engineer for the Washington State Department of Transportation and returned to serve as NDOT's Deputy Director for southern Nevada. Mr. Malfabon was recently appointed as Director of NDOT by Governor Brian Sandoval. He is a graduate civil engineer from the University of Nevada, Reno, and is a registered professional engineer in Nevada and Washington.

Bill Hoffman is the Deputy Director of NDOT where he has worked for almost 22 years. He is responsible for assisting the Director in the daily operations of the Department, which has more than 1,750 full-time employees who plan, construct, operate, and maintain 5,400 miles of roads and 1,000 bridges that make up the State highway system. Mr. Hoffman has a bachelor's degree in civil engineering from the University of Nevada, Reno, and is a registered professional engineer in Nevada.

Jered McDonald works as a Senior Research Analyst within the Legislative Counsel Bureau, a position he has held since June 2012. Previously, he worked at the Department of Employment, Training and Rehabilitation for 10 years, the last six as a Supervising Economist. Mr. McDonald has a bachelor of science degree in environmental policy analysis and a master of science degree in resource and applied economics from the University of Nevada, Reno.

Jennifer Ruedy has been with the Research Division of the Legislative Counsel Bureau since 2001, having worked three prior sessions for the Assembly and Senate. She spent her first five years with the Research Division in the Constituent Services Unit (CSU), serving as the Assistant Manager of CSU her last two years. Jennifer has served as the primary Policy Analyst for several legislative committees. She earned her master of international management degree from the American Graduate School of International Management at the Thunderbird Campus, with an emphasis on international finance, and her bachelor of arts degree in Spanish from Arizona State University.
