The data exchange improved information available to state policymakers. Sharing data between the four states made it possible to determine where college students ended up after graduation for 7 percent more college graduates than the states would have known about from their own standalone data; the number of students found after graduation would increase if data were available from more states.

Over 60 percent of recent college graduates remained in the state where they graduated for at least the year after graduation. The data also show that the incidence was even greater among recent high school graduates of the states. Earnings can vary significantly. Perhaps not surprisingly, recent college graduates' earnings can vary significantly—by as much as 50 percent when one looks beyond overall earnings rates to things like field of study and whether graduates continue in their studies as they work. And, from a cross-state data exchange such as this, one can also look at how earnings vary for graduates who remain in state to work or go elsewhere."
