ASSEMBLY BILLS SPONSORED BY
DONALD MELLO
(*PRIME SPONSOR)

A.B. 8 – Fazzini, Harris, Jean, Schouweiler, Webb, Mello, Wooster, Torvinen, Foote, Garfinkle, McKissick, and Wood.
Establishes Grand Army of the Republic Civil War Cemetery. (BDR 35-306). Died in Senate Committee on Finance.

A.B. 70 – Bishop, Dungan, Harris, Brookman, Tyson, Mello, Manning, May, Garfinkle, Fazzini, Hilbrecht, Schouweiler, and Dini.
Allows State Fire Marshal to appoint deputies. (BDR 42-222). Chapter 382.

A.B. 110 – Bowler, Howard, Mello, and Ashworth.
Proposes additional grounds for revocation, suspension of barbers' licenses. (BDR 54-295). Chapter 269.

A.B. 111 -- Bowler, Howard, Mello, and Ashworth.
Limits exclusion of cosmetologists from coverage of barber's license law. (BDR 54-296). Died in Assembly Committee on Public Health and Public Morals.

A.B. 112 -- Bowler, Howard, Mello, and Ashworth.
Provides for licensing of barber shops. (BDR 54-229). Chapter 270.

A.B. 123 – Brookman, Bishop, May, Hilbrecht, Bryan Hafen, Wilson, White, Mello, Harris, Garfinkle, Schouweiler, and Fazzini.
Empowers political subdivisions to purchase disability insurance to guarantee salaries to disabled firemen. (BDR 23-216). Died in Senate Committee on Federal, State, and Local Governments.

A.B. 140 -- Bowler, Howard, Mello, Ashworth, and May.
Reconstitutes State Barbers' Health and Sanitation Board, (BDR 54-231). Chapter 271.

*A.B. 273 – Mello.
Requires railroads to dispose of livestock killed or injured on railroad right-of-way within specified time. (BDR 58-724). Died in Assembly Committee on Roads, Transportation, and Aviation.

A.B. 317 – Schouweiler, Garfinkle, Foote, Dungan, Brookman, Harris, and Mello.
Fixes average maximum work week for firemen. (BDR 21-220). Died in Assembly Committee on State, County, and City Affairs.

A.B. 343 – Bowler, Ashworth, Tyson, May, White, Close, Espinoza, Hilbrecht, Tim Hafen, Frank Young, Wilson, Bishop, Brookman, Wood, Jacobsen, Foote, Harris, Keane, Homer, Getto, Mello, Wooster, Manning, and Prince.

Exempts real estate of certain fraternal organizations from taxation. (BDR 32-126). Chapter 358.

A.B. 379 – Mello, Howard, Viani, May, Ashworth, Homer, and Smith.

Authorizes special fishing permits for patients in Nevada State Hospital. (BDR 45-1096). Chapter 218.

A.B. 403 – Manning, Garfinkle, Wilson, Close, Mello, White, Harris, May, Viani, Bishop, Prince, Wood, Bowler, Espinoza, Dungan, Foote, and Fazzini.

Established temporary disability benefit system for employees. (BDR 53-1080). Died in Assembly Committee on Labor.

A.B. 413 – Wooster and Mello.

Provides for Legislative Commission Study if Reno-Sparks Voters approve consolidation of cities. (BDR S-1097). Died in Select Committee of the Assemblymen from Washoe and Storey Counties.

Makes application to Congress to call a constitutional convention. (BDR 892). Died in Assembly Committee on Elections.
