Clarifies state gaming license due dates and penalties. (BDR 41-494).
Chapter 134.
- A.B. 47 – Foote, Wilson, Brookman, Espinoza, Webb, and Mello.
Allows children receiving ADC benefits to use their earnings for education.
(BDR 38-844). Died in Assembly Committee on Health and Welfare.
- A.B. 72 – Frank Young, Hilbrecht, Close, Tim Hafen, Capurro, Mello, Torvinen,
Bowler, Dini, Webb, and Wood.
Allows uninsured motorist coverage up to limits of insured's policy. (BDR 57-
755). Died in Senate Committee on Judiciary.
- A.B. 73 – Hilbrecht, Wilson, Espinoza, Brookman, May, and Mello.
Requires Nevada Industrial Commission to pay legal costs when claimant
perfects successful appeal or succeeds in civil action against commission. (BDR
53-276).
- A.B. 170 – Close, Ashworth, Bowler, Branch, Brookman, Bryan, Dini, Espinoza,
Foote, Glaser, Hilbrecht, May, Mello, Prince, Reid, Swackhamer, and Viani.
Enacts fair housing law. (BDR 10-713). Died in Assembly Committee on
Judiciary.
- A.B. 235 – Hilbrecht, Dini, Mello, Branch, Glaser, Brookman, Bryan, Espinoza,
Bryan Hafen, Tyson, Reid, Bowler, May, Foote, Swackhamer, Viani, Close,
Ashworth, and Prince.
Requires fiscal analyst to prepare study of cash flow of public moneys to
minimize amount in active deposits. (BDR 31-1291). Chapter 513.
- A.B. 273 – Close, McKissick, Foote, Mello, Bowler, and Lowman.
Provides for a commissioner of civil marriages. (BDR 11-1222). Chapter 439.
- A.B. 305 – McKissick, Lowman, Jacobsen, Howard, Bowler, Bryan Hafen, Glaser,
Ashworth, Getto, Bryan, Smith, Homer, Reid, Frank Young, May, Capurro, Foote,
Wood, Mello, Espinoza, Brookman, Wilson, Frazzini, Schouweiler, Branch, Tyson,
Hilbrecht, Fry, and Viani.
Proposes Constitutional Convention. (BDR S-666). Died in Assembly
Committee on Ways and Means.

A.B. 334 – Kean, Jacobsen, Howard, May, Ashworth, Reid, Tim Hafen, Glaser, Bryan, Lingenfelter, Fry, Torvinen, Hilbrecht, Capurro, Mello, Getto, and Swackhamer.

Requires state agencies to write shorter reports. (BDR 19-1202). Died in Senate Committee on Federal, State, and Local Governments.

A.B. 401 – Branch, Mello, May, and Frazzini.

Requires 30 days' notice before writ of garnishment may issue. (BDR 3-1411). Died in Assembly Committee on Judiciary.

A.B. 411 – Brookman, Tim Hafen, Branch, Espinoza, Foote, Frazzini, Getto, Howard, May, Mello, and Wilson.

Clarifies pay provisions, enlarges leaves of absences for Nevada National Guard. (BDR 36-331). Died in Assembly Committee on Ways and Means.

A.B. 417 – Branch, Lingenfelter, Mello, Dini, and Prince.

Requires approval of public employees before investing retirement fund moneys in municipal bonds. (BDR 23-1585). Died in Assembly Committee on Government Affairs.

A.B. 447 – Brookman, Branch, Dini, Bryan, Espinoza, Frazzini, Getto, Bryan Hafen, Tim Hafen, Hilbrecht, May, Mello, Prince, Schouweiler, Smith, Viani, and Wilson.

Empowers political subdivisions to purchase insurance to guarantee salaries to disabled employees. (BDR 23-1375). Died in Assembly.

A.B. 458 – Branch, Mello, May, Schouweiler, Wilson, Tim Hafen, Bowler, Bryan, Espinoza, Wood, and Hilbrecht.

Provides that annual audit of funds and accounts of local governments should be made under supervision of Nevada Tax Commission. (BDR 31-1583). Died in Senate Committee on Federal, State, and Local Governments.

A.B. 492 – Mello, Howard, Close, Branch, May, Wilson, and Schouweiler.

Provides compensation for members of State Apprenticeship Council. (BDR 53-1406). Chapter 444.

A.B. 522 – May, Bowler, Branch, Dini, Viani, Getto, Tyson, Wilson, Swallow, Bryan Hafen, Brookman, Howard, Tim Hafen, Lowman, and Mello.

Allows resale price maintenance contracts for alcoholic beverages. (BDR 52-969). Died in Assembly Committee on Commerce.

A.B. 677 – Hilbrecht, Bryan, Lingenfelter, Fry, Dini, Viani, Kean, Brookman, Bryan Hafen, Smith, Schouweiler, Espinoza, Frazzini, May, Mello, Homer, Branch, Wilson, Tim Hafen, Capurro, Foote, Prince, Swallow, and Bowler.

Abolishes the Legislative Commission. (BDR 17-1560). Died in Assembly Committee on Legislative Functions.

A.B. 707 – Close, Bowler, and Mello.

Regulates credit rating bureaus. (BDR 54-1670). Died in Assembly Committee on Commerce.

A.B. 752 – Wood, May, Prince, Swallow, Capurro, Mello, Jacobsen, Howard, Kean, Getto, Viani, Dini, Lingenfelter, Branch, Espinoza, Glaser, Ashworth, Bowler, Bryan Hafen, Frank Young, Foote, Frazzini, Swackhamer, Roy Young, Smith, Brookman, Tim Hafen, Homer, Tyson, Webb, Wilson, and Lowman.

Limits attorneys' fees in civil actions. (BDR 2-1782). Died in Select Committee of the Assemblymen from Clark County District No. 5.

Memorializes Congress to provide for election of President by popular vote. (BDR 951). Died in Senate Committee on Judiciary.

Proposes to amend Constitution by permitting temporary exemptions from property tax for improvements. (BDR C-1210). Died in Assembly Committee on Taxation.
