

### **INTRODUCTION**

**This section of the Transportation System Projects document contains the ANNUAL WORK PROGRAM, SHORT RANGE ELEMENT, and LONG RANGE ELEMENT listed by County.**

**The ANNUAL WORK PROGRAM (AWP) includes:**

**Construction projects NDOT intends to start work on or participate in during the current Federal Fiscal Year 2009;**

**Construction projects NDOT plans to award to contractors; and**

**Major Maintenance work initiated by NDOT which may be completed by the end of the Federal Fiscal Year 2009.**

**The AWP is considered the Department's capital improvement program for the current Federal Fiscal Year 2009. All projects are subject to the availability of state and federal funds as well as staff resources. Problems in financing, engineering, right-of-way acquisitions, or revised priorities may delay the completion of any project listed.**

**The SHORT RANGE ELEMENT (SRE) includes:**

**Construction projects proposed for Federal Fiscal Year 2010 through 2011,**

**Construction projects NDOT plans to award to contractors, and**

**Major maintenance work initiated by NDOT, which may be completed by the end of the Federal Fiscal Year 2011.**

**The LONG RANGE ELEMENT (LRE) identifies:**

**Construction projects the State, the four Metropolitan Planning Organizations, and local governments would like to have initiated within Federal Fiscal Years 2012 through 2018.**
