In 2007, the Legislature appropriated money to enable the Research Division of the Legislative Counsel Bureau to create an oral history of the Nevada Legislature. (Section 17 of chapter 345, Statutes of Nevada 2007, p. 1605) This bill establishes the Nevada Legislature Oral History Program in statute to provide for the ongoing conduct and preservation of oral histories of current and former Legislators. The Program is required to be administered by the Research Division.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 218A of NRS is hereby amended by adding thereto a new section to read as follows:

- 1. The Nevada Legislature Oral History Program is hereby established, to be administered by the Research Division.
- 2. Within the limits of money available, the Research Division shall cause the conduct and preservation of oral histories of current and former Legislators.
 - 3. The Research Division shall:
- 9 (a) Prepare a plan setting forth any oral histories proposed to 0 be conducted during a biennium and submit the plan to the 1 Legislative Commission for its approval.



(b) With the approval of the Legislative Commission, adopt procedures for the conduct and preservation of the oral histories and any related materials, including, without limitation, books, papers, documents, records, photographs and recordings.

- (c) With the approval of the Legislative Commission, adopt policies:
- (1) Governing the acceptance by the Research Division of oral histories of current and former Legislators and any related materials submitted by any person or public or private entity. Such policies must include, without limitation, policies relating to the format for submitting, and the standards for the acceptance of, such an oral history and any related materials.
- (2) Governing the release to the public of oral histories conducted or accepted pursuant to this section and any related materials.
- (3) Governing the transfer of oral histories conducted or accepted pursuant to this section and any related materials to the Division of State Library and Archives of the Department of Administration pursuant to subsection 6.
 - (4) Necessary to carry out the Program.
- 4. The Director may accept any gifts, grants or donations for the support of the Program. All money received for the Program pursuant to this subsection must be credited to the Legislative Fund. The Legislative Counsel Bureau shall maintain separate accounting records for the receipt and expenditure of that money.
- 5. An oral history conducted or accepted for the Program pursuant to this section and any related materials are confidential and may only be released to the public pursuant to the policy adopted pursuant to subsection 3.
- 6. The Research Division may transfer an oral history conducted or accepted for the Program pursuant to this section and any related materials to the Division of State Library and Archives of the Department of Administration for preservation.
- 7. On or before September 1 of each even-numbered year, for the biennium ending June 30 of such year, the Research Division shall submit a report to the Legislative Commission concerning the activities of the Program during that biennium.

2. A governmental entity may not reject a book or record which is copyrighted solely because it is copyrighted.

- 3. A governmental entity that has legal custody or control of a public book or record shall not deny a request made pursuant to subsection 1 to inspect or copy or receive a copy of a public book or record on the basis that the requested public book or record contains information that is confidential if the governmental entity can redact, delete, conceal or separate the confidential information from the information included in the public book or record that is not otherwise confidential.
- 4. A person may request a copy of a public record in any medium in which the public record is readily available. An officer, employee or agent of a governmental entity who has legal custody or control of a public record:
- (a) Shall not refuse to provide a copy of that public record in a readily available medium because the officer, employee or agent has already prepared or would prefer to provide the copy in a different medium.
- (b) Except as otherwise provided in NRS 239.030, shall, upon request, prepare the copy of the public record and shall not require



the person who has requested the copy to prepare the copy himself or herself.

- **Sec. 3.** NRS 378.240 is hereby amended to read as follows:
- 378.240 The State Library and Archives Administrator shall, within the limits of legislative appropriations:
- 1. Maintain and properly equip safe and secure premises and vaults at the seat of government for the preservation and use of material deposited in the archives.
- 2. Employ persons in the classified service of the State to preserve, index and aid in the use of material deposited in the archives.
- 3. Give an appropriate receipt for material received by him or her for the archives.
- 4. Subject to the provisions of NRS 378.310 and subsection 4 of NRS 239.090, make material deposited in the archives readily available for use.
- 5. Receive into the archives any material when directed to do so by the Committee to Approve Schedules for the Retention and Disposition of Official State Records created pursuant to NRS 239.073.
- 6. Receive into the archives and preserve oral histories of current and former Legislators and any related materials transferred from the Research Division of the Legislative Counsel Bureau pursuant to section 1 of this act.
 - **Sec. 4.** This act becomes effective upon passage and approval.

This legislation would establish the Nevada Legislature Oral History Program in statute to provide for the ongoing conduct and preservation of oral histories of current and former legislators. Although the Research Division would be tasked with preparing a plan setting forth the oral histories proposed to be conducted during a biennium for the approval of the Legislative Commission, we have indicated that the bill will not have a fiscal impact on the Research Division. Since the legislation does not require the Research Division to conduct any particular number of oral histories in any given biennium, the Division will propose to the Legislative Commission that it conduct only as many oral histories as it can complete within its existing budgetary resources. The Administrative Division's Broadcast and Production Services Unit can assist with a limited number of such histories as time permits.

If appropriations are approved for the program at any point or if gifts or donations are received pursuant to the legislation, the additional funds could be used to obtain outside assistance conducting the oral histories and enable the completion of more histories than would otherwise be possible.

I cannot imagine anyone having questions about removing boards that are not doing anything. Is anyone in support of the bill? [There was no one.] Is there anyone opposed to the bill? <u>Assembly Bill 384:</u> Establishes the Nevada Legislature Oral History Program. (BDR 17-1011)

Assemblywoman Heidi Swank, Assembly District No. 16:

Joining me today is Assemblywoman Amber Joiner, who will start off the presentation on Assembly Bill 384, and then I will join her.

Assemblywoman Amber Joiner, Assembly District No. 24:

The purpose of <u>A.B. 384</u> is to formalize in statute the Nevada Legislature's Oral History Project which has been dormant for the last six years. In 2007, <u>Senate Bill No. 579 of the 74th Session</u> appropriated funds to enable the Research Division of the Legislative Counsel Bureau (LCB) to create an oral history of the Nevada Legislature.

Between 2008 and 2009, I was fortunate enough to be assigned as a project coordinator for this project while serving as a Senior Research Analyst for LCB. We contracted with a skilled oral history team to conduct 17 videotaped and audiotaped interviews of former legislators who had made significant contributions in the state. Highlights from these interviews were compiled into a half-hour video that some of you may have seen either at Old Timer's Day in the last several sessions or at the freshman orientation. It was called "Remembering Citizen Legislators: The Nevada Legislative Oral History Project." You should have a have a two-page handout in front of you (Exhibit L). There is a fact sheet and also a list of all the oral histories we have currently. There is a transcript, video, and audio for each of them. The compilation video is at the top of the page if you want to click on it and watch it. In these videos, you will see a veritable treasure trove of historical nuggets. You will hear everything from fun anecdotes to factoids that give a glimpse of how Nevadans lived. Also, there is timeless wisdom shared on how to represent constituents and how to work across party lines. I find it fascinating that a lot of the policy issues they grappled with in these oral history interviews are some of the same ones we still work hard to overcome, the many challenges involved with equal rights, education, and how to fund essential services. We can learn a lot by listening to our predecessors.

Chair Stewart:

One of the first people you should interview is Assemblyman Munford if this bill passes. This man has a wealth of information on history. Would you agree to that, Assemblyman Munford?

Assemblyman Munford:

Yes.

Assemblywoman Joiner:

Despite how amazing these videos were, since the project ended in 2009, no additional oral histories have been conducted and no additional funds have been allocated to the project. Unfortunately, since those interviews, we have lost five interview participants. The reason I bring this up is because in the subsequent six years, we were unable to conduct oral histories on people because they had passed away. For me, this is a time-sensitive issue. I hate to miss anymore legendary legislators who have a lot to offer in these histories by not moving forward with this bill this session.

This bill has a fiscal note of zero because it does not require that the LCB conduct a certain number of oral histories. It stays within the limits of available money. It also provides that the Research Division will propose a plan to the Legislative Commission for conducting legislative oral histories and a budget proposal prepared during their normal budgeting process. The bill will be explained by Assemblywoman Swank, and after her explanation, we have a Nevada historian, Dana Bennett, with us who was the main interviewer in the original project, as well as other supporters who were involved in the project. Before I conclude, on your fact sheet you will notice that it is prepared by Amber Joiner and Donald Williams. Mr. Williams is Director of the Research Division, and I received word from him that he was not able to make it here today, but he supports the bill and worked incredibly hard on this project.

Assemblywoman Swank:

Section 2 gives the Research Division of LCB the permission to protect and preserve these oral histories as money is available.

Subsection 3 states that the Research Division must submit a plan to the Legislative Commission for approval of this project and that the plan should include procedures for conducting and preserving oral histories and related materials. This could be books, documents, or whatever the individual would like to add to their oral history. They also must develop policies which would include a format for any oral histories that were done externally. So if there was someone who had his own oral history prepared, he could submit it as long as it met the standards that were set in this plan by the Research Division for

the oral history and related materials. The policies deal with release of the oral histories and related materials to the public. This is important because one of the things that I want to include in this plan is that we could interview current legislators, not just past legislators. Looking at this as an anthropologist, in your first legislative session, there are a lot of things that seem remarkable but in later sessions, they seem less remarkable and become part of the flow of the Legislature. We want to make sure that people who are going to continue to run for office would not need to release their oral histories until they no longer run for office. They would have that control. The policies would have to cover the transferring of oral histories and related materials to the Division of State Library and Archives, and any other additional policies that are needed for the program.

Subsection 4 allows the director of the Research Division to accept gifts, grants, and donations for the program. As you retire from the Legislature, you can make donations to help keep the history of this body alive.

Subsection 5 states that the oral histories are to be kept confidential and there must be a policy for their release to be developed by the Research Division and approved by the Legislative Commission. This refers back to protecting legislators' information.

Subsection 6 states that the Research Division can transfer the oral histories and related materials to the Nevada State Library and Archives.

Subsection 7 outlines the reporting requirements for the program.

The long list of numbers in subsection 8 exempts this program from the requirement that all books and records of a government entity be made public. This also protects legislators' information as long as they want it protected.

Chair Stewart:

Are both of you going to be in this program?

Assemblywoman Swank:

I hope to be.

Assemblywoman Joiner:

Yes, I would love to.

Assemblyman Trowbridge:

I think this may seem like a fluff project but it is not. I have been involved in programs such as this, and they are incredibly important. The only thing

I would suggest to enhance it would be to involve someone from the library early on in the process just because of the way things are organized and how librarians think.

Chair Stewart:

Assemblywoman Joiner, do you know where the early interviews are kept?

Assemblywoman Joiner:

The original idea was to keep them in the LCB Research Library, which is where they are currently. The only time I envisioned the State Library and Archives being involved is if for some reason the Research Library ran out of space or if it was determined through the Legislative Commission's approval and plan that there was a need to transfer them. I believe we have the capacity to keep them here at the Legislature.

Chair Stewart:

Ms. Stonefield tells me that is where they are. Is there anyone in support of this bill?

Dana Bennett, Private Citizen, Reno, Nevada:

I am here as the former project manager of the Nevada Legislature Oral History Project.

Chair Stewart:

I believe you are the first historian to head up the Nevada Mining Association, correct?

Dana Bennett:

Yes, and the first woman. I began working at the Research Division of the Legislative Counsel Bureau in December 1988. During my ten years in the Division, I developed a deep interest in the history of this institution. I worked on the revision of the political history of Nevada in 1996 and published several articles related to legislative history, one of which was co-authored with my former boss, Lorne Malkiewich.

Recently I completed a doctor of philosophy (Ph.D.) in history with a dissertation that focused on Nevada women lawmakers and their involvement in tax policy development before 1960. While I was a history doctoral student, I was part of a group that successfully bid for the job of conducting oral histories that Assemblywoman Joiner described. Over that 18-month period, I had the privilege and the joy of interviewing some of Nevada's legendary legislators, such as Senator Virgil Getto, who I believe has the distinction of being a freshman five times. One of the people who got me to thinking about

this process was Senator Jack Vergiels, who I believe is the only person to have served as both the Speaker of the Assembly and Senate Majority Leader. Senator Vergiels started telling me fantastic stories, and I wanted to get them recorded but that did not happen. He was on the list of people to be interviewed as part of the Legislature's Oral History Project, but he had become ill and deteriorated very quickly. So, we lost those stories.

That is emblematic about the importance of this project. As the project manager, I interviewed more than half of them and was able to capture an interview with William D. "Bill" Swackhamer who first served in the Legislature in 1947 as Speaker and eventually became Secretary of State. It was a privilege and a lot of fun. The importance of oral history is that it captures the color commentary. The legislative record, history, and journals are the play-by-play, but the color commentary is when the people involved tell you what happened in the back rooms. In the records there is information about when the state Senate passed the Equal Rights Amendment (ERA) in the 1970s, but until you hear Senator Joseph M. "Joe" Neal explain how he maneuvered that, you do not get a full understanding of what really happened. I am happy to answer any questions.

Lorne Malkiewich, Private Citizen, Reno, Nevada:

I am here today as a former employee of the Legislative Counsel Bureau (LCB). I was employed by the LCB for 30 years; 18 years as Director, and I also participated in the original oral history project. I am strongly in favor of the bill and in continuing this project. I spent a number of years in charge and loved every minute of it. I had the pleasure of working with many of the legislators who were interviewed as part of this project. I have worked with Assemblyman Ohrenschall's mother, was hired by his stepfather, worked with Assemblywoman Neal's father, and with Senator Segerblom's mother. I think the bill is very well done to put it in the Research Division and have the Legislative Commission approve it. There is no cost and it is within the limits of appropriation allowing gifts, grants, and working with the State Library and Archives. I think it is a wonderful project and I encourage your support.

Chair Stewart:

Assemblywoman Swank, I think we could expand this bill to not only include legislators but those who worked in the Legislative Building. I think these two people in front of us, plus the legislator to my right, would be excellent people to interview. Is there anyone else in support of <u>A.B. 384</u>? [There was no one.] Is there anyone opposed to this bill? [There was no one.] Is anyone neutral to this bill? [There was no one.] Assemblywoman Joiner and Assemblywoman Swank, I have one condition on passing this bill, which is that both of you need to consult with me as to the list of people who need

to be interviewed. I think on the top of that list would be former Assemblyman John C. Carpenter. I would appreciate being involved with that input. The hearing is closed on $\underline{A.B.\ 384}$. Is there any public comment? [There was none.] The meeting is adjourned [at 6:12 p.m.].

The purpose of the Nevada Legislature Oral History Project is to conduct and archive the interviews of former legislators who have made significant historical contributions to our State. By making the recordings and transcripts available to the public, it is hoped that the stories captured will enhance the historical understanding of public policy, political culture, and the legislative process in Nevada.

Between 2008 and 2009, the Nevada Legislature Oral History Project conducted 17 video-and audio-taped interviews of former legislators who have made significant contributions to Nevada. In commemoration of the Legislature's 75th Regular Legislative Session, portions of 16 of the interviews were compiled into a 27-minute film titled, "Remembering Citizen Legislators: The Nevada Legislature Oral History Project." Transcripts and videos of all the interviews are now available to the general public for purchase through the Gift Shop of the Legislative Counsel Bureau (LCB). The following libraries and museums have also received a set of transcripts and videos: the Research Library of the LCB; the Nevada State Library and Archives; the Mathewson-IGT Knowledge Center at the University of Nevada, Reno; the Lied Library at the University of Nevada, Las Vegas; the Nevada Historical Society; and the Nevada State Museum, Las Vegas.

The interviews are topical interviews lasting between one and two hours. They focus on important projects, events, and legislation in which the legislator played a leadership role during his or her legislative career. The interviews attempt to capture the unofficial history of the Nevada Legislature by asking questions about the portion of the legislator's life relevant to his or her term(s) in office. Some common themes include how he or she came to serve in the Nevada Legislature, his or her most significant contribution to the legislative process or public policy in Nevada, and "what it was really like" behind the scenes at the Legislature.

PARTICIPANTS

Several factors were considered when identifying former legislators to be interviewed. Some factors included age, length of legislative tenure, contributions to the State of Nevada, and whether a formal oral history of the individual had been published or was underway. The final list provided to the contractor reflected a careful balance of legislative house, political party, and geographic distribution among the interviewees. The following former legislators have been interviewed to date:

BACKGROUND

During the 74th Legislative Session in 2007, the Nevada Legislature approved Senate Bill 579 (Chapter 345, *Statutes of Nevada 2007*), which appropriated funds to the Legislative Fund for the Research Division of the LCB to create an oral history of the Nevada Legislature. During the same legislative session, another measure that would have allocated funds for the Project, Senate Bill 373, was considered by the Senate Committee on Finance. Testimony proposing the Project was provided at the April 4, 2007, Committee meeting, but no action was taken.

The Research Division of the LCB conducted a competitive bid process to identify and retain a contractor to carry out the project. A committee consisting of LCB and other State personnel with expertise in Nevada history and politics evaluated and ranked the proposals received, which included applicants from across the country. In January 2008, a contract was signed between the LCB and Get Consensus, LLC, for an 18-month program, which ended in June 2009.

Mr. Powers:

As far as the Category E felony, under NRS 193.130, generally, when you are sentenced to a Category E felony, the judge provides for a minimum term of not less than 1 year and a maximum term of not more than 4 years. However, except in serious violent crimes, a Category E felony requires the judge to suspend the sentence and enter a sentence of probation. There is not a jail time sentence with a Category E felony as long as a violent crime is not involved.

Mr. Frank:

I support this bill. I had the impression <u>A.B. 461</u> and <u>A.B. 177</u> were not in conflict, would deal with the same statute and would be merged in some way to not conflict. Am I right about this?

Mr. Powers:

Yes, that is correct. The provisions of these two bills were crafted so if both bills are enacted, they can be fused together in codification without conflict.

Mr. Frank:

Thank you. I support both bills.

Mr. Anderson:

Assembly Bill 461 is a much narrower bill than A.B. 177. It gives some teeth to the law and may be a deterrent to candidates filing for election in a district where they do not live.

Chair Farley:

I will close the hearing on A.B. 461 and open the hearing on A.B. 384.

<u>ASSEMBLY BILL 384:</u> Establishes the Nevada Legislature Oral History Program. (BDR 17-1011)

Assemblywoman Heidi Swank (Assembly District No. 16):

This bill would establish a Nevada Legislature Oral History Program.

Assemblywoman Amber Joiner (Assembly District No. 24):

The purpose of this bill is to formalize in statute the Nevada Legislature Oral History Program, which has been dormant for the last 6 years. I have submitted my written testimony (<u>Exhibit F</u>). We also have a handout with information about the original project that took place in 2008 and 2009 (Exhibit G).

Don Williams, the former research director of the Legislative Counsel Bureau (LCB) who was involved in the last Oral History Program, was unable to be here today but sends his strong support in the form of a letter (Exhibit H).

Assemblywoman Swank:

Section 1, subsection 2 specifies that oral histories will be collected and preserved as money is available. Section 1, subsection 3 directs the Research Division of the LCB to submit a plan to the Legislative Commission for approval. This plan should include procedures for conducting and preserving the oral histories and any related materials.

The plan would also include policies, such as the format for submitting externally conducted oral histories. Some Legislators have brought in their own oral histories, and we want to match the formats and standards, both for the oral history and the material.

Policies also deal with the release of oral histories and related materials to the public. This is about Legislators having control over the release of their own information. We would like to see oral histories of current Legislators who are early in their career, not just experienced Legislators. These would be held and kept confidential until the Legislator authorized the release or passed away. The aim of the Program is to not release information the subject would be uncomfortable with. Another policy of concern is to govern the transfer of the oral histories and related materials to the Division of State Library and Archives of the Department of Administration.

Section 1, subsection 4 allows the Director of the Research Division to accept gifts, grants and donations for the Program.

Section 1, subsection 5 states that all oral histories are confidential and must follow the policies for their release developed by the Research Division and approved by the Legislative Commission.

Section 1, subsection 6 says the Research Division may transfer the oral history and related materials to the Division of State Library and Archives of the Department of Administration.

Section 1, subsection 7 lays out additional requirements for the Program. Section 2 of the bill states that this program is exempt from the requirement

that all public books and records of a government entity be made public. This is because we will be collecting the oral histories of current Legislators, and we want to ensure those are kept confidential until ready to be released.

Senator Brower:

Before this Session started, I was thinking about what this place must have been like in the 1860s, 1870s and 1880s. I assumed someone had written a book about it, but it does not appear that anyone has. Senators Segerblom and Settelmeyer have probably heard family stories about what it was like, but the rest of us do not get the chance to hear those stories. I support this bill.

Senator Segerblom:

Did Mark Twain say something about the Nevada Legislature in his writing? Is there immunity in case Legislators say things they did were illegal, so you cannot come after Legislators until after they die?

Assemblywoman Swank:

I would suggest that Legislators not disclose illegal acts.

Lorne Malkiewich:

I support <u>A.B. 384</u>. I am the living fossil here, having worked in the 1980s with many of the people who had their oral histories completed. I worked on that project and with many of the Legislators involved. You know you are old when you have worked with the parents of Legislators. I worked with Senator Segerblom's mother, and I worked with Alan Glover from the Office of the Secretary of State when he was Senator Glover. This is a good bill with no fiscal impact.

Mr. Frank:

I support the concept of this bill and think it is long overdue. Are all members of both the Assembly and Senate eligible for oral histories? I would hope everyone would qualify because I would like to know more about the new as well as the old members of the Legislature. The histories of all of our people willing to serve the public should be preserved.

Assemblywoman Joiner:

In the original Oral History Program, we used several criteria in choosing the first wave of subjects. We did try to choose Legislators who had made large contributions, but we also wanted a variety from rural and urban areas and

different political parties. The vision we have with this bill and this phase of oral histories is that all Legislators would be eligible, and every year the LCB would look at its budget and prioritize them. Some Legislators could contribute their own oral histories and add them to the collection.

Mr. Frank:

I would encourage all the new members of the Legislature as well as the experienced members to collect your information as you go along because the public would like to know what you have to say about your service, no matter how long it is. That would be a good thing to do as a matter of discipline.

Chair Farley:

I will close the hearing on A.B. 384 open the work session.

Michael Stewart (Policy Analyst):

The first bill we are addressing is <u>A.B. 23</u>, an election bill from the Office of the Secretary of State heard on April 29. I have submitted a work session document explaining this bill (Exhibit I).

ASSEMBLY BILL 23 (1st Reprint): Makes various changes to provisions governing elections. (BDR 24-446)

SENATOR SETTELMEYER MOVED TO AMEND AND DO PASS AS AMENDED A.B. 23.

SENATOR BROWER SECONDED THE MOTION.

Senator Atkinson:

I think I remember the amendment. Did it come after the passage from the other House?

Mr. Anderson:

There was an amendment put in through the Assembly side. We had added "independent" in four different spots, but it should have only gone into two. The amendment on this side is to take those two out.

Senator Atkinson:

Thank you. Our legal counsel just showed it to me.

Testimony Assembly Bill 384

Assemblywoman Amber Joiner May 6, 2015

- The purpose of AB 384 is to formalize in statute the Nevada Legislature's Oral History Project, which has been dormant for the last 6 years.
- In 2007, Senate Bill 579 appropriated funds to enable the research division of LCB to create an oral history of the Nevada Legislature.
- Between 2008 and 2009, I was fortunate to be assigned as the project coordinator for the Project while serving as a Senior Research Analyst at the Legislative Counsel Bureau (LCB). We contracted with a very skilled oral history team to conduct 17 video and audio taped interviews of former legislators who made significant contributions to NV.
- Highlights from the interviews were compiled into a half hour video to commemorate the Legislature's 75th Regular Legislative Session called "Remembering Citizen Legislators: The Nevada Legislature Oral History Project"
 - Some of you may have seen it at old timer's day or freshman orientation, where it has been shown;
 - o It is available on the LCB website (see the handout); and
 - The participants in the project at that time, and details about how they were conducted are also in the handout provided.
- In these oral histories, you will find
 - A treasure trove of historical nuggets and humorous stories that reveal what life was like in Nevada overall.
 - Timeless wisdom about how to be an effective representative of the people and serve our constituents, as well as advice about how best to collaborate across the aisle.
 - o It is also fascinating to see that many of the policy issues they were grappling with in the past are still some of the ones we find most challenging today. For example, we are still debating the best way to provide Education, and how to fund essential services.

- Unfortunately, since the project ended in 2009, no additional oral histories have been added and no additional funds have been allocated. Since the interviews, 5 of the participants have passed away, and just in the last six years we have missed out on capturing stories from several other legislators who we have lost.
- This bill has a fiscal note of zero, because it does not require that a certain number of oral histories be conducted. Instead, it requires LCB to conduct and preserve oral histories within the limits of money available. It also provides that LCB will propose a plan for conducting oral histories to the legislative commission as part of their regular budgeting process.

The purpose of the Nevada Legislature Oral History Project is to conduct and archive the interviews of former legislators who have made significant historical contributions to our State. By making the recordings and transcripts available to the public, it is hoped that the stories captured will enhance the historical understanding of public policy, political culture, and the legislative process in Nevada.

Between 2008 and 2009, the Nevada Legislature Oral History Project conducted 17 video-and audio-taped interviews of former legislators who have made significant contributions to Nevada. In commemoration of the Legislature's 75th Regular Legislative Session, portions of 16 of the interviews were compiled into a 27-minute film titled, "Remembering Citizen Legislators: The Nevada Legislature Oral History Project." Transcripts and videos of all the interviews are now available to the general public for purchase through the Gift Shop of the Legislative Counsel Bureau (LCB). The following libraries and museums have also received a set of transcripts and videos: the Research Library of the LCB; the Nevada State Library and Archives; the Mathewson-IGT Knowledge Center at the University of Nevada, Reno; the Lied Library at the University of Nevada, Las Vegas; the Nevada Historical Society; and the Nevada State Museum, Las Vegas.

The interviews are topical interviews lasting between one and two hours. They focus on important projects, events, and legislation in which the legislator played a leadership role during his or her The interviews attempt to capture the unofficial history of the legislative career. Nevada Legislature by asking questions about the portion of the legislator's life relevant to his or her term(s) in office. Some common themes include how he or she came to serve in the Nevada Legislature, his or her most significant contribution to the legislative process or public policy in Nevada, and "what it was really like" behind the scenes at the Legislature.

PARTICIPANTS

Several factors were considered when identifying former legislators to be interviewed. Some factors included age, length of legislative tenure, contributions to the State of Nevada, and whether a formal oral history of the individual had been published or was underway. The final list provided to the contractor reflected a careful balance of legislative house, political party, and geographic distribution among the interviewees. Included in the collection is an oral history of Joseph Dini's wife, Mouryne B. Landing Dini. Mrs. Dini served as the Chief Clerk of the Nevada State Assembly from 1973 to 1995.

BACKGROUND

During the 74th Legislative Session in 2007, the Nevada Legislature approved Senate Bill 579 (Chapter 345, *Statutes of Nevada 2007*), which appropriated funds to the Legislative Fund for the Research Division of the LCB to create an oral history of the Nevada Legislature. During the same legislative session, another measure that would have allocated funds for the Project, Senate Bill 373, was considered by the Senate Committee on Finance. Testimony proposing the Project was provided at the April 4, 2007, Committee meeting, but no action was taken.

The Research Division of the LCB conducted a competitive bid process to identify and retain a contractor to carry out the project. A committee consisting of LCB and other State personnel with expertise in Nevada history and politics evaluated and ranked the proposals received, which included applicants from across the country. In January 2008, a contract was signed between the LCB and Get Consensus, LLC, for an 18-month program, which ended in June 2009.

Assembly Bill No. 79.

Bill read third time.

Remarks by Senator Settelmeyer.

Assembly Bill No. 79 deletes obsolete provisions related to State grazing boards and revises the procedures for determining the compensation of owners of animals destroyed due to infection or exposure to dangerous diseases. The bill also provides for the deposit of administrative fines for violation of statutes relating to the control of diseases in animals into a loan program for persons 21 years of age or younger who are engaged in agriculture and the Account for the Control of Weeds. The measure also revises the exclusions from the definition of "food establishment." With respect to statutes affecting agricultural products and seeds, the bill adds civil penalty provisions for the violation of such statutes and repeals the criminal penalties. Finally, A.B. 79 repeals criminal penalties applicable to the regulation of garlic and onions and to the regulation of commercial livestock feed. The bill is effective on July 1, 2015.

Assembly Bill No. 79 having received a constitutional majority, Mr. President declared it passed.

Assembly Bill No. 144.

Remarks by Senator Goicoechea.

Assembly Bill No. 144 sets forth the legislative intent that members of the Executive Council of the State Land Use Planning Advisory Council (SLUPAC) should be representative of the geographic areas of the State. The bill also transfers responsibility for making recommendations and adopting proposed regulations for land use planning involving areas of critical environmental concern from the Executive Council to the SLUPAC. The bill is effective on July 1, 2015.

The bill was a recommendation of the Sunset Subcommittee of the Legislative Commission from the 2013–2014 Interim. Senate Bill No. 510 authorizes certain employees of the Legislative Branch of Government to transfer, as part of the normal transfer process afforded to other State employees in the classified service, to any position in the classified service of the State for which he or she is qualified, without regard to the duties and compensation of the position. These provisions apply only to employees of the Legislative Branch who have served four consecutive months or more in the Legislative Branch. The bill is effective upon passage and approval.

Existing law allows Legislative Branch employees to transfer to positions having similar duties and compensation in the classified service of the State on the same basis as other employees within the Executive Branch. This includes an exemption from a competitive examination, the retention of annual and sick leave credits, and the listing of priority for eligible employees. Testimony indicated that many employees of the Legislative Branch have unique jobs and may be well-qualified for a transfer position in the classified service, but their specific duties and compensation do not match the available position. Senate Bill 510 clarifies that a Legislative Branch employee, if qualified, may transfer into such available classified positions without regard to the specific duties and compensation of the position.

Senate Bill No. 391, as amended, requires the board of trustees of each school district and the governing body of each charter school to prepare a plan to improve the literacy of students enrolled in kindergarten through grade 3. The principal of each public elementary school must designate a learning strategist to train and assist teachers in providing intensive instruction to students identified as deficient in reading. Certain teachers are required to complete related professional development.

This bill requires academic interventions for students enrolled in kindergarten through grade 3 who do not achieve adequate proficiency in reading, and beginning in School Year 2019–2020 prohibits a public school from promoting a student to grade 4 if the student does not achieve such proficiency, with certain good-cause exemptions allowed. A student may only be retained one time in grade 3.

The principal of a school is required to: provide notice and offer additional instructional options to the parent or legal guardian of a student who will be retained in grade 3; develop a plan to monitor the progress of the student in achieving reading proficiency; and Ensure that a retained student receives intensive instructional services in reading, as prescribed by the school district board of trustees or charter school governing body.

General Fund appropriations totaling \$5.0 million in FY 2016 and \$22.5 million in FY 2017 are included in The Executive Budget to fund this major budget initiative.

Senate Bill 391, as amended, is effective upon passage and approval for the purpose of adopting regulations and performing other preparatory administrative tasks; on July 1, 2015, for the purpose of providing literacy supports for students in kindergarten through grade 3; and on July 1, 2019, for the purpose of retaining students who are not proficient in reading. Mr. President, this bill is the result of a lot of peoples hard work, but particularly our colleague from Senate District 9. She should be commended for focusing such intensive services on students who need it the most and this should certainly improve education in our State.

Senate Bill No. 483 provides for the continuation of certain revenue enhancements enacted during the 2013 Session that are set to expire on June 30, 2015, and provides for the implementation of new revenue enhancements recommended by the Governor in The Executive Budget. With respect to the revenue enhancements enacted during the 2013 Session, the bill removes the June 30 2015, sunset date on the 0.35% increase to the Local School Support Tax, which makes the increase permanent.

It maintains the current structure of the Modified Business Tax on Nonfinancial Institutions (MBT-NFI) with the exemption for the first \$85,000 in taxable wages per quarter and the rate of 1.17% on all taxable wages over \$85,000 per quarter and makes this structure permanent.

It continues the prepayment of the Net Proceeds of Minerals Tax and maintains the exclusion of certain industrial and health insurance deductions for FY 2016 only.

It extends the sunset date on the requirement for a portion of the Governmental Services Tax proceeds to be deposited in the State General Fund from June 30, 2015 to June 30, 2017. The proceeds from the 10% increase in the depreciation schedule that was enacted during the 2009 Session would be deposited in the State Highway Fund beginning on July 1, 2017.

CHAPTER 183

[Approved: May 25, 2015]

AN ACT relating to the Legislature; establishing the Nevada Legislature Oral History Program; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

In 2007, the Legislature appropriated money to enable the Research Division of the Legislative Counsel Bureau to create an oral history of the Nevada Legislature. (Section 17 of chapter 345, Statutes of Nevada 2007, p. 1605) This bill establishes the Nevada Legislature Oral History Program in statute to provide for the ongoing conduct and preservation of oral histories of current and former Legislators. The Program is required to be administered by the Research Division.

EXPLANATION - Matter in bolded italics is new; matter between brackets [omitted-material] is material to be omitted.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 218A of NRS is hereby amended by adding thereto a new section to read as follows:

1. The Nevada Legislature Oral History Program is hereby

established, to be administered by the Research Division.

2. Within the limits of money available, the Research Division shall cause the conduct and preservation of oral histories of current and former Legislators.

3. The Research Division shall:

(a) Prepare a plan setting forth any oral histories proposed to be conducted during a biennium and submit the plan to the Legislative Commission for its approval.

(b) With the approval of the Legislative Commission, adopt procedures for the conduct and preservation of the oral histories and any related materials, including, without limitation, books, papers, documents, records, photographs and recordings.

(c) With the approval of the Legislative Commission, adopt policies:

- (1) Governing the acceptance by the Research Division of oral histories of current and former Legislators and any related materials submitted by any person or public or private entity. Such policies must include, without limitation, policies relating to the format for submitting, and the standards for the acceptance of, such an oral history and any related materials.
- (2) Governing the release to the public of oral histories conducted or accepted pursuant to this section and any related materials.
- (3) Governing the transfer of oral histories conducted or accepted pursuant to this section and any related materials to the Division of State Library and Archives of the Department of Administration pursuant to subsection 6.

(4) Necessary to carry out the Program.

- 4. The Director may accept any gifts, grants or donations for the support of the Program. All money received for the Program pursuant to this subsection must be credited to the Legislative Fund. The Legislative Counsel Bureau shall maintain separate accounting records for the receipt and expenditure of that money.
- 5. An oral history conducted or accepted for the Program pursuant to this section and any related materials are confidential and may only be released to the public pursuant to the policy adopted pursuant to subsection 3.
- 6. The Research Division may transfer an oral history conducted or accepted for the Program pursuant to this section and any related materials to the Division of State Library and Archives of the Department of Administration for preservation.
- 7. On or before September 1 of each even-numbered year, for the biennium ending June 30 of such year, the Research Division shall submit a report to the Legislative Commission concerning the activities of the Program during that biennium.

This section does not supersede or in any manner affect the federal laws governing copyrights or enlarge, diminish or affect in any other manner the rights of a person in any written book or record which is copyrighted pursuant to federal law.

2. A governmental entity may not reject a book or record which is

copyrighted solely because it is copyrighted.

3. A governmental entity that has legal custody or control of a public book or record shall not deny a request made pursuant to subsection 1 to inspect or copy or receive a copy of a public book or record on the basis that the requested public book or record contains information that is confidential if the governmental entity can redact, delete, conceal or separate the confidential information from the information included in the public book or record that is not otherwise confidential.

4. A person may request a copy of a public record in any medium in which the public record is readily available. An officer, employee or agent of a governmental entity who has legal custody or control of a public record:

(a) Shall not refuse to provide a copy of that public record in a readily available medium because the officer, employee or agent has already

prepared or would prefer to provide the copy in a different medium.

(b) Except as otherwise provided in NRS 239.030, shall, upon request, prepare the copy of the public record and shall not require the person who has requested the copy to prepare the copy himself or herself.

Sec. 3. NRS 378.240 is hereby amended to read as follows:

378.240 The State Library and Archives Administrator shall, within the

limits of legislative appropriations:

- 1. Maintain and properly equip safe and secure premises and vaults at the seat of government for the preservation and use of material deposited in the archives.
- 2. Employ persons in the classified service of the State to preserve, index and aid in the use of material deposited in the archives.

3. Give an appropriate receipt for material received by him or her for

the archives.

- 4. Subject to the provisions of NRS 378.310 and subsection 4 of NRS 239.090, make material deposited in the archives readily available for use.
- 5. Receive into the archives any material when directed to do so by the Committee to Approve Schedules for the Retention and Disposition of Official State Records created pursuant to NRS 239.073.
- 6. Receive into the archives and preserve oral histories of current and former Legislators and any related materials transferred from the Research Division of the Legislative Counsel Bureau pursuant to section 1 of this act.
