Library Note

In the five meetings marked 4/2/69 and/or 4/3/69, there are certain details that are irreconcilable with either the Assembly Journal or other meetings, such as the apparent co-occurrence in time of some meetings. This leads Library Staff to conclude that it is likely some of the meetings are incorrectly dated. However, there is insufficient data present to make an accurate determination of when the meetings actually occurred. Therefore, these meetings will be labeled as they were originally, with the addition of an A-E to represent the order in which they were found in State Archives' files, and for indexing purposes.

55th SESSION

The meeting was called to order by Chairman R. Young at 11:45 A.M. in the Ways and Means Room.

Present: R. Young, Howard, Bowler, Ashworth, Webb, Jacobsen, Glaser, F. Young

Absent: Close

Mr. Jim Bailey and Mr. Shute were present to discuss S.B. 80 which raises fee for certifying that certain mobile home equipment is properly installed.

Senator Pozzi discussed S.B. 191 Which increases vehicle registration fee for benefit of Nevada Highway Patrol.

Senator Pozzi stated that this was a Traffic Safety Program. For each car, bus, truck, etc. there will be an additional fee of \$1 which shall be placed in a special fund for the use and support, through augmentation of the personnel of the Highway Patrol. Any balance remaining shall be deposited in the State Highway Fund in the Treasury.

S.B. 25 Shortens time for courts to notify Department of Motor Vehicle of traffic convictions; provides method of canceling demerit points.

Mr. Bailey stated that this was a way of getting the people to work towards improving their driving habits. It will remove 5 demerits in one year.

Mr. Sullivan and Mr. Questa were present to discuss A.B. 600 Which relieves County Recorders of the duties relating to marriage certificates.

Mr. Sullivan stated that this will take the recording of marriages away from the County Recorder, the certificate will come directly to Carson City. Mr. Sullivan also commented that there were between 90,000 and 92,000 marriage certificates recorded a year.

The State would gain \$1 per copy. The bill must be amended to direct recorders

Mr. Glaser moved that a letter be written to Mr. Sullivan stating that we study the problems relating to streamling the procedures or marriage certificates.
Mr. F. Young seconded the motion.
Motion passed unanimously.

It was also requested that Mr. Sullivan send a Revised Budget back to the Ways and Means Committee.

Mr. F. Young moved that <u>the bill</u> which makes General Fund appropriation to State Controller to implement Fiscal and Accounting procedures Law be introduced by the Ways and Means Committee.
Mr. Ashworth seconded the motion.
Motion passed unanimously.

Meeting adjourned at 12:40 P.M.
