

Dear Mr. Bruce:

In order that there may be a clear understanding of the request by the Labor Commissioner for additional support funds to the 1969-70 and 1970-71 Budget, I submit the following:

Justification for a Chief Assistant, together with that of contract services for obtaining legal services to assist the Commissioner in the legal processing of Nevada Labor and Industrial Relations Laws in the Courts of Nevada's 17 counties, which have been recognized and made a part of the aforementioned Budget. However, support funds, through oversight, were not included.

Howard Barrett, Director, Department of Administration, appeared with the Commissioner of Labor before the Senate Finance Committee and Assembly Ways and Means Committee and supported the following requested increases for the 1969-70 and 1970-71 Budget:
