Chairman Vergiels called the meeting to order at 3:28 p.m. in Room 214.

AB 652 - Out of deference to Mr. Goodman who has a similar corporal punishment bill, Mr. Horn moved an Indefinite Postponement on his bill, AB 652. Mr. Schofield seconded and the committee unanimously approved.

AB 644 - Chairman Vergiels appointed a subcommittee of Mr. Goodman, Assemblyman Lloyd Mann, Attorney Robert Petroni and Ms. Joyce Woodhouse to work out problems contained in Mr. Goodman's corporal punishment bill.

AB 679 - Mr. Goodman read a prepared statement, Exhibit A, supporting his bill which would require a proficiency test for teachers.

Ms. Woodhouse suggested, on behalf of the NSEA, that the tests should better be directed toward the university system as a graduation requirement. Mr. Horn concurred that waiting until after graduation is too late to institute such a test, stating his opinion that the bill attacks the problem one step too late and questioning the fiscal impact of such a bill which would require formulation, administration, grading of a test and possible remedial work. Mr. Rhoads wondered whether any other state has such a law and how teachers proved incompetent could be let go. Ms. Woodhouse pointed out there is a dismissal act and Mr. Goodman stated it is his intent to require this test of new teachers only. The chairman suggested he and Mr. Goodman meet to work out a fiscal note and report back to the committee.

AB 688 - Ann Hibbs, Nevada Nurses Association, stated the bill serves only Washoe County which does not currently have an immunization clinic and interferes with one already operating successfully in Clark County. Her comments are attached as Exhibit B.

Mrs. Gomes, one of the sponsors of this bill, explained that there is some confusion surrounding the bill and stated her intention to withdraw the bill and pursue locally with Mrs. Wagner the matter of requiring immunization for certain diseases for registration in public school. Accordingly, Mrs. Gomes moved an Indefinite Postponement. Mr. Schofield seconded and the committee unanimously approved the motion.

AB 704 - Mr. Vergiels explained this bill proposes enabling legislation for school districts to set up special purpose schools if they desire; e.g., a science high school. In answer to Mr. Schofield, he replied that these schools would operate on the same schedule and same funding as present schools. He suggested deleting any section, such as lines 20 - 22, which deal with specifics. Robert Cox, attorney for Washoe County, stated that districts already are engaged in this practice and he does not consider this necessary legislation. Mr. Schofield moved to Indefinitely Postpone this bill. Mr. Rhoads seconded. Mr. Goodman cast the only "no" vote.

AB 711 - This bill which would permit rental of school buses to certain nonprofit groups was sponsored by Mrs. Brookman.

Mr. Robert Best, Executive Secretary of the Nevada School Trustees Association, said a similar bill was killed last session because the districts try to retain their flexibility and enter into agreements with governmental units to provide services to groups, like city recreation, but try not to compete with private enterprise. Mr. Cox stated his opinion that this will lead to less freedom for use of buses rather than more. Mr. Horn suggested that the phrase "composed principally of persons over 60 years of age," lines 4 and 5, be deleted. Mr. Goodman moved a Do Pass as Amended and Mr. Kissam seconded. The committee unanimously concurred.

AJR 54 - Mr. Horn spoke to this resolution which would memoralize Congress to propose a constitutional amendment prohibiting busing of public school children for purposes of racial balance. Mr. Horn stated that he feels busing to bring about racial balance is not working and gave a brief history, discussing "separate but equal" and "separate cannot be equal" and saying that since (1) busing takes children out of their neighborhood schools; (2) busing causes children to spend excessive time being transported; (3) busing is excessively expensive; (4) busing is disruptive of and interferes with education; and (5) only a constitutional amendment can correct this, therefore, Mr. Horn urged adoption of his resolution.

Mrs. Gomes took exception to Mr. Horn's statements, speaking for equality of education and integration to make it effective and stating her opinion that such a resolution as this would be a step backwards. Mr. Horn moved a Do Pass, seconded by Mr. Schofield and was supported by Mr. Kissam, Mr. Rhoads and Mr. Schofield and opposed by Mrs. Gomes, Mr. Goodman and Mr. Vergiels.

SB 352 - The summary states that this bill revises probationary status provisions for certain educational personnel in categorical grant positions but there was general confusion as to the intent of the bill and the possibility that it could mean that persons hired with federal grant money would have to be retained after the grant no longer existed. Mr. Goodman moved for Indefinite Postponement and Mr. Rhoads seconded. Mr. Schofield cast the only "no" vote.

The chairman announced the committee would review any outstanding bills Wednesday, April 20, and the meeting was adjourned at 4:38 p.m.

INFORMATION CONCERNING A.B. 679

Academic achievement among students in public schools throughout the nation has been on a steady decline for about 20 years.

Verbal and mathematical ability of students has dropped every year for 14 consecutive years, according to scores on the College Entrance Examination Board's Scholastic Aptitude Test (SAT). Scores on American College Testing Program (ACT) tests have also fallen during the past 11 years for which data are available.

This alarming deterioration of basic reading, writing, speaking, thinking, and mathematics skills among public school students nation—wide is not restricted just to the one million college preparatory students who take SAT and ACT tests nationwide each year. This tragic decline of basic everyday skills is also occurring in the lower elementary and junior high school grades, where the learning of such skills will determine a person's success or failure during his entire working life.

The suggested Teacher Proficiency Act is designed to help stop and reverse the decline in basic academic skills among students at all grade levels, in public schools in all the states.

It simply requires that teachers themselves—as a prerequisite for being awarded educator certificates—be able to pass a test demonstrating their own proficiency in basic reading, writing, grammar, spelling, and mathematics in order to obtain a tax-salaried teaching or school administration job in the public school system.

Nevada State Health Division is opposed to all of the proposed amendments to the Nevada Immunization Law, as set forth in AB 688.

It appears that it may be a regional bill to serve the only School Districts in the State (Washoe) which at this time do not have <u>Immunization Clinics actually</u> held in the schools.

Clark County School District has gone to a great deal of trouble and expense to computerize its student immunization records. The proposed amendments in AB 688 would be ruinous to the Clark County computerized immunization record system.

The Bill would allow doing away with immunization surveys presently performed by the schools, but those surveys fulfill a federal reporting requirement and would have to be done in any event.

The effectiveness of Immunization programs is often reflected in the numbers of Measles cases reported in communities. Note that the numbers of cases of Measles reported to us in 1976 was:

SUBJECT:

ANNUAL IMMUNIZATION SURVEY

As per Nevada Statutes we are asking that each of the school districts report on the immunity level of their students by December 31, 1976.

We have enclosed the form for the survey. It is the same document used for last year's survey so that we may assess the improvement of each of the districts in gaining immunity for its students.

You will note that we are only requiring a record audit of the normal school entering class. (i.e., kindergarten or first grade.) If your audit system is computerized for a larger group or you feel a wider survey is necessary for your administrative needs then please note the additional population on the form and submit it.

We ask that each of the superintendents review the results of the survey when it is complete. If your level is below 85% in any given area there are enough susceptible students to support an epidemic.

My office can arrange for immunization clinics in your schools at no charge to the district or to the student. We urge you to request this service if your survey indicates a need.
