**PROCLAMATION OF SPECIAL ELECTION TO BE HELD
IN STATE OF NEVADA ON JUNE 8, 1971**

I, JOHN KOONTZ, the duly elected, qualified and acting Secretary of State of the State of Nevada, do hereby certify that the fifty-sixth session of the Nevada State Legislature, by the provisions of Chapter 494, (A. B. No. 220) Statutes of Nevada 1971, authorized and directed the Secretary of State to issue, and promulgate this Special Election Proclamation, in the following form, viz:

SPECIAL ELECTION PROCLAMATION

NOTICE IS HEREBY GIVEN that on Tuesday, June 8, 1971, at the voting place of each precinct and voting district in the State of Nevada a special election will be held for the adoption or rejection by the registered voters of the state of the following proposed amendment of section 1 of article 2 of the constitution of the State of Nevada:

Section 1. All citizens of the United States (not laboring under the disabilities named in this constitution) of the age of [twenty-one] *eighteen* years and upwards, who shall have actually, and not constructively, resided in the state six months, and in the district or county thirty days next preceding any election, shall be entitled to vote for all officers that now or hereafter may be elected by the people, and upon all questions submitted to the electors at such election; provided, that no person who has been or may be convicted of treason or felony in any state or territory of the United States, unless restored to civil rights, and no idiot or insane person shall be entitled to the privilege of an elector. There shall be no denial of the elective franchise at any election on account of sex. The legislature may provide by law the conditions under which a citizen of the United States who does not have the status of an elector in another state and who does not meet the residence requirements of this section may vote in this state for President and Vice President of the United States.

(The matter in italics in the proposed amendment is proposed new language; the matter in brackets [] is the language proposed to be omitted.)

QUESTION NO. 1

Shall section 1 of article 2 of the constitution of the State of Nevada be amended to reduce the minimum voting age from 21 years to 18 years?

Yes..... 37,142
No..... 35,577

(Explanation of Question)

The proposed amendment to section 1 of article 2 of the constitution of the State of Nevada would reduce the minimum voting age to 18 years.

A “yes” vote is a vote to reduce the minimum voting age to 18 years. A “no” vote is a vote not to reduce the minimum voting age to 18 years and to leave the minimum voting age at 21 years.
