#### CALL TO ORDER AND OPENING REMARKS

- Herbert E. Randall, Ed.D., Forum President, called the Nevada Silver Haired Legislative Forum's (NSHLF) meeting to order. President Randall welcomed guests and members of the public.
- Ms. Shope conducted the roll call and a quorum was determined to be present.

• President Randall called for public comment; however, no testimony was presented.

## APPROVAL OF MINUTES OF THE MEETING HELD ON JUNE 17, 2014, IN LAS VEGAS, NEVADA

• President Randall presented the minutes of the June 17, 2014, meeting for review and approval.

#### The NSHLF APPROVED THE FOLLOWING ACTION:

LUCY PERES MADE A MOTION TO APPROVE THE MINUTES OF THE JUNE 17, 2014, MEETING HELD IN LAS VEGAS, NEVADA. THE MOTION WAS SECONDED BY STEPHANIE L. ROSE.AND PASSED UNANIMOUSLY.

# DISCUSSION AND APPROVAL OF THE TREASURER'S REPORT, WHICH INCLUDES THE LATEST AVAILABLE BUDGET REPORTS, APPROVAL OF RECENT EXPENDITURES, AND PROPOSED EXPENDITURES

• Lonnie Strait, Forum Treasurer, reviewed the budget and expenditures of the Nevada Silver Haired Legislative Forum, as of November 18, 2014 (Exhibit B).

#### The NSHLF APPROVED THE FOLLOWING ACTION:

VERLIA DAVIS HOGGARD MADE A MOTION TO APPROVE THE TREASURER'S REPORT AND EXPENDITURES ENDING NOVEMBER 18, 2014. THE MOTION WAS SECONDED BY LUCY PERES AND PASSED UNANIMOUSLY.

# DISCUSSION AND APPROVAL OF THE NEVADA SILVER HAIRED LEGISLATIVE FORUM'S SUMMARY REPORT SUBMITTED TO THE LEGISLATIVE COMMISSION AND THE GOVERNOR, SEPTEMBER 2014

- President Randall opened the discussion and solicited feedback from Forum members regarding the Summary Report to the Legislative Commission and the Governor, September 2014 (Exhibit C). He requested minor corrections to Recommendation No. 3 regarding Housing Services.
- Ray B. Jones, Forum Member, shared his support for the Summary Report.
- President Randall suggested Forum members follow the Forum's Bill Draft Request
  (BDR) No. 38-415 ("Revises provisions governing the long-term care ombudsman.")
  using the Legislative Counsel Bureau's Personalized Legislative Tracking (PLT).
  Ms. Shope shared the timetable for the Summary Report printing and stated the Forum
  members would receive complementary copies. In addition, Ms. Shope indicated the
  Summary Report would be presented to the Governor and the Legislative Commission
  for approval.

#### The NSHLF APPROVED THE FOLLOWING ACTION:

JAMES DOWNER MOVED TO APPROVE THE NSHLF SUMMARY REPORT TO THE LEGISLATIVE COMMISSION AND THE GOVERNOR, SEPTEMBER 2014 WITH THE MINOR CORRECTIONS AS NOTED BY PRESIDENT RANDALL. THE MOTION WAS SECONDED BY LUCY PERES AND PASSED UNANIMOUSLY.

## STATUS REPORT ON THE NATIONAL SILVER HAIRED CONGRESS (NSHC) AND NATIONAL COUNCIL OF SILVER HAIRED LEGISLATORS (NCSHL)

- President Randall reported on the NSHC's 16th Annual Conference, held in August 2014. He referenced the NSHC's Top Five Resolutions, which are included in the Forum's Summary Report (Exhibit C). President Randall shared the results of the NSHC's Election of Officers. He reported he was elected Chairman of the Board of Directors, Lucy Peres was elected First Vice-Chair, and Lonnie Strait was elected Treasurer. He indicated the top challenges for the NSHC included membership growth and fundraising.
- Ms. Peres introduced the newest member of the Nevada Delegation, Mary D. Roberts, Silver Representative.
- Ms. Davis Hoggard reported on the NCSHL. She mentioned she was elected as the First Vice-President of the Council. She provided the preliminary information for the 2015 Annual Conference.

### REPORTS FROM NSHLF MEMBERS AND DISCUSSION OF SENIOR CONCERNS

- Ms. Shope informed the Forum members that Melisa Aguon was recently selected as the Legislative Services Officer, Administrative Division, Las Vegas Office.
- Reba June Burton, Forum Member, inquired about the Forum's brochure success. Ms. Shope stated the brochure has assisted with the outreach efforts. President Randall requested the Forum members provide their legislators with the brochure and the Summary Report.
- Ms. Davis Hoggard encouraged Forum members to personally notify their legislators about the Summary Report.

#### DISCUSSION OF FUTURE AGENDA ITEMS AND POSSIBLE MEETING DATES

- President Randall opened the discussion on future agenda items, meeting dates, and expenditures. Ms. Shope mentioned that Forum members would be informed of legislative dates for committee hearings and the Older Americans Day at the Legislature.
- Barbara Altman, Forum Member, suggested Aging and Disability Services Division (ADSD) representatives be invited as speakers at a future meeting.
- Ms. Burton encouraged Forum members to participate in the 2015 Legislative Session. She requested a summary of the legislative session.
- President Randall referred to AARP's CARE Act (the Caregiver Advise, Record, Enable Act) and requested the Forum support this proposed legislation. (Exhibit D)

#### **PUBLIC COMMENT**

- John Yacenda, Forum Member, requested representatives from ADSD highlight their legislative agenda. Dr. Yacenda and Ms. Burton shared their gratitude for their services and dedication to seniors.
- Jill R. Berntson, Deputy Administrator, Chief, Elder Rights Division, ADSD, stated the Division is requesting additional staffing for ombudsman and elder rights protection programs.
- Heather Korbulic, State Long-Term Care Ombudsman, ADSD, extended her appreciation for the Forum's BDR No. 38-415. In addition, Ms. Korbulic stated BDR No. S-417 ("Revises provisions relating to facilities for skilled nursing.") would be introduced to improve direct nursing care staffing.

• Sally Ramm, Elder Rights Attorney, ADSD, provided an overview of the proposed BDRs that address senior issues.

#### **ADJOURNMENT**

There being no further business to come before the Forum, President Randall entertained a motion to adjourn.
