NOTICE OF WORKSHOPS TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

May 18, 1998

The Department of Business and Industry, Division of Insurance (Division) is proposing the amendment of regulations pertaining to chapters 679B, 688A, 688B and 695C of the Nevada Administrative Code. A workshop has been set for 10:00 a.m., on June 25, 1998, at the offices of the Division, 1665 Hot Springs Road, Suite 152, Carson City, Nevada. The purpose of the workshop is to solicit comments from interested persons on the following general topics addressed in the proposed regulations.

- 1. Amendments to chapters 679B and 695C of NAC. The proposed regulation:
 - (a) Establishes a fee of \$15 for a returned check;
 - (b) Adds unfair trade practices as an authorized use of the fraud assessment;
 - (c) Establishes HIV reporting requirements for insurers;
 - (d) Repeals the regulations for the Office of Hospital Patients;
 - (e) Provides for the payment of commissions to agents by HMOs;
 - (f) Establishes time limits for the filing of provider lists by HMOs.
- 2. Amendments to chapter 688A and 688B of NAC. The proposed regulation establishes guidelines of the use of the Annuity 2000 Mortality Table, 1994 GAR Table, 1993 GAM Table and the 1983 Table "a".

NOTICE OF INTENT TO ACT UPON REGULATIONS

Notice of Hearing for the Amendment of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance (Division) will hold a public hearing at 2:00 p.m., on June 25, 1998 at the offices of the Division, 1665 Hot Springs Road, Suite 152, Carson City, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations pertaining to chapters 679B and 695C of the Nevada Administrative Code.

REGULATIONS FOR RETURNED CHECKS, USE OF FRAUD ASSESSMENT, HIV REPORTING, OFFICE OF HOSPITAL PATIENTS, COMMISSION PAYMENTS BY HMOs, and FILING OF PROVIDER LISTS BY HMOs.

The following information is provided pursuant to the requirements of NRS 233B.060:

- 1. The proposed regulation is needed to establish standards for returned checks, use of the fraud assessment, reporting requirements for insurers, and to repeal outdated regulations.
- 2. The amendments include: a \$15.00 fee for returned checks; the addition of unfair trade practices as an authorized use of the fraud assessment; HIV reporting requirements for insurers; payment of commissions by HMOs; deadlines for the filing of provider lists by HMOs; and the repeal of regulations regarding the Office of Hospital Patients.
- 3. Estimated economic effect of the regulation:

On the business which it is to regulate:

- (a) The amendments should have little beneficial impact on the industry.
- (b) The amendments may have both an immediate and long-term adverse impact on insurance companies for the on-going reporting requirements for HIV testing, and for the fees for returned checks.

On the public:

The amended regulation should have no economic impact on the public.

- 4. The Division anticipates a nominal expense to enforce the proposed regulation.
- 5. The Division is not aware of any overlap or duplication of the regulation with any state, local or federal regulation.
- 6. The proposed regulation establishes a new fee for checks returned to the Division due to insufficient funds.

Persons wishing to comment upon the proposed action of the Division may appear at

the scheduled public hearing or may address their comments, data, views or arguments, in written form, to the Division, 1665 Hot Springs Road, Suite 152, Carson City, Nevada 89706. Written submissions must be received by the Division on or before June 19, 1998. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Division may proceed immediately to act upon any written submissions.

PROPOSED REGULATION OF THE DIVISION OF INSURANCE

STATE OF NEVADA DEPARTMENT OF BUSINESS AND INDUSTRY DIVISION OF INSURANCE

REGULATION FOR:

- 1. FEES FOR A RETURNED CHECK;
- 2. ADDITION OF UNFAIR TRADE PRACTICES AS AN AUTHORIZED USE OF THE FRAUD ASSESSMENT;
- 3. HIV REPORTING REQUIREMENTS FOR INSURERS;
- 4. REPEAL OF REGULATIONS FOR THE OFFICE OF HOSPITAL PATIENTS;
- 5. PAYMENT OF COMMISSIONS BY HMOs; and
- 6. FILING OF PROVIDER LISTS BY HMOs

Authority: NRS 679B.130, 679B.153 and 679B.228

- Section 1. Chapter 679B of NAC is hereby amended by adding thereto the provisions set forth as sections 2 to 5, inclusive, of this regulation.
- Sec. 2. The division will charge a fee of \$15 for each check returned to the division because the person had insufficient funds or credit with the drawee to pay the check or because the person stopped payment on the check.
- Sec. 3. Insurers that require or request any applicant or other person who is a resident of, or is physically located in, the State of Nevada, to be examined or tested with any medical, clinical, or laboratory test that yields evidence of a communicable disease as defined in NAC 441A.040, shall be subject to the same reporting requirements as a health care provider, as set forth in NAC 441A.230.
- Sec. 4. Insurers that request or require any applicant, or other person, to surrender a

specimen to be tested for the presence of Human Immunodeficiency Virus (HIV), HIV antibodies, or CD4 T-lymphocyte counts, shall comply with the following:

- 1. Before obtaining a specimen the insurer is to:
- (a) Counsel the applicant or person from whom the specimen is to be obtained, regarding HIV and the test to be used.
- (b) Give the applicant or other person the opportunity to designate and authorize a health care provider, as defined in NAC 441A.110, to receive any positive, reactive, indeterminate or abnormal test results.
- (c) Inform the applicant, or other person, that if he or she does not designate a health care provider, the local health authority will be notified of any positive, reactive, indeterminate, or abnormal test results, for notification, counseling and appropriate referral.
- 2. Any report of a positive, reactive, indeterminate, or abnormal results, by the insurer to the health authority, is to include the name, address, and telephone number of the health care provider that was sent the test results.
- Sec. 5. 1. The Nevada State Board of Health shall have the authority to regulate or specify what HIV laboratory tests may be used by insurers.
 - 2. The Nevada State Board of Health shall have the authority to regulate or specify which medical laboratories may be used by insurers to perform HIV laboratory test.

Sec. 6. NAC 679B.154 is hereby amended to read as follows:

- 1. The commissioner will determine the assessment for the special investigative account by dividing the amount of money [appropriated] <u>authorized</u> by the legislature for that year for the support of the program to investigate fraudulent claims <u>and compliance with chapter 686A of NRS</u> by the number of insurers who hold a certificate of authority in this state as of June 1 of the year of assessment.
- 2. The [department] division will mail to each company a notice of the amount of the assessment on or before July 1 of each year.

- Sec. 7. NAC 679B.760 to 679B.774, inclusive, is hereby repealed.
- Sec. 8. NAC 695C.150 is hereby amended to read as follows:

A person shall not solicit or sell to any group or person any health care plan which provides for comprehensive health care services unless he:

- 1. Has a valid <u>agent or broker</u> license to sell health insurance issued by the commissioner;
- 2. Has been appointed by the organization if licensed as an agent; and
- 3. Meets all other requirements for an agent <u>or broker</u> licensed to sell health insurance.
- Sec. 9. Subsection 2 of NAC 695C.200 is hereby amended to read as follows:
 - 2. The health maintenance organization shall notify:
 - (a) the division and the state board of health in writing [at] not later than 14 days after the end of each quarter of each calendar year of any changes in its list of providers. A request for an extension of time to file the list must be submitted to the commissioner before the day on which the list is due. An extension for not more than 30 days may be granted by the commissioner; and
 - (b) An enrollee in writing of the disassociation of his primary physician from the organization not later than 30 days after such disassociation.
