TEMPORARY REGULATION OF THE DAIRY COMMISSION

INFORMATIONAL STATEMENT

RE: NAC 584.6051

NAC 584.6051 APPEARED AS AN ACTION ITEM ON THE MARCH 19, 1998 DAIRY COMMISSION MEETING AGENDA IN LAS VEGAS AND A WORK SESSION AGENDA ON MARCH 20, 1998 IN RENO, APRIL 16, 1998 AT RENO, MAY 21, 1998 AT LAS VEGAS, JUNE 18, 1998 AT RENO.

NOTICES OF THOSE MEETINGS WERE POSTED IN WESTERN NEVADA MARKETING AREA AND SOUTHERN NEVADA MARKETING AREA. PUBLIC COMMENT WAS SOLICITED AT EACH OF THE MEETINGS. ALL PERSONS WHO ARE ON THE DAIRY COMMISSION MAILING LIST, BY REQUEST, ALSO RECEIVED COPIES OF THE MEETING NOTICES.

MINUTES OF EACH MEETING WAS TAKEN BY A CERTIFIED COURT REPORTER. TRANSCRIPTS ARE AVAILABLE FOR REVIEW AND COPYING IN BOTH RENO AND LAS VEGAS OFFICES OF THE COMMISSION.

THERE IS NO ECONOMIC AFFECT ON THE INDUSTRY, THE CONSUMERS, OR THE AGENCY. NO ADDITIONAL COST WILL BE INCURRED IN THE ENFORCEMENT OF THIS REGULATION. THIS TEMPORARY REGULATION DOES NOT DUPLICATE IN ANY MANNER ANY OTHER REGULATIONS OF THE DAIRY COMMISSION OR OTHER AGENCY AT ANY LEVEL OF GOVERNMENT.

WE WOULD LIKE TO ADD THE ATTACHED "PARAGRAPH 4" TO OUR EXISTING NAC 584.6051 TO ADOPT AS A TEMPORARY REGULATION.

ADD PARAGRAPH (4) TO NAC 584.6051

(4) A DISTRIBUTOR MAY FURNISH, WITHOUT CHARGE, BUNKERS TO A WHOLESALE CUSTOMER DURING AN ACTIVE PROMOTIONAL PERIOD. THE BUNKERS WILL NOT EXCEED THE 52" SIZE AND THE PROMOTIONAL PERIOD WILL NOT EXCEED NINETY (90) DAYS. THE BUNKERS WILL BE USED EXCLUSIVELY FOR DAIRY PRODUCTS. THIS REGULATION WILL EXPIRE ON JULY 1, 1999 UNLESS REVIEWED AND EXTENDED BY THE DAIRY COMMISSION.
