Section 1. NAC 364.020 is hereby amended to read as follows:

Payment to department. A governing body shall pay to the department [three eighths of all proceeds of the tax] the amounts required pursuant to NRS 244.3354(1)(a), NRS 244.3354(2)(a), NRS 268.0962(1)(a), and NRS 268.0962(2)(a); within 30 days after the date on which the tax is to be paid to the governing body.
