# PROPOSED REGULATION OF THE DIVISION OF INSURANCE OF THE DEPARTMENT OF BUSINESS AND INDUSTRY

### NOTICE OF WORKSHOPS TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

October 22, 1999

The Department of Business and Industry, Division of Insurance (Division) is proposing new regulations pertaining to captive insurance companies, health insurance for small employers and eligible persons, health maintenance organizations, and service contracts. A workshop has been set for 10:00 a.m., on December 1, 1999, at the offices of the Division, 1665 Hot Springs Road, Suite 152, Carson City, Nevada. The purpose of the workshop is to solicit comments from interested persons on the following general topics addressed in the proposed regulations.

- 1. Captive Insurance Companies. The proposed regulation establishes requirements for the filing of an annual report, the minimum standards for an annual audit, requirements for deposits, and standards for reinsurance. The regulation also prescribes the application form and the letter of credit.
- 2. Health Insurance for Small Employers and Eligible Persons. The proposed regulations limit the use of medical questionnaires, requires the use of disclosure forms, and prohibits tied insurance sales.
- 3. Health Maintenance Organizations. The proposed regulations allow fee for service arrangements with providers, amends provisions regarding reserves for premium taxes, and payment on statutory bonds.
- 4. Service Contracts. The proposed regulations establish the fees and documents that must be filed, requirements for claims, and the processing of terminated contracts.
- 5. Workers' Compensation. The proposed regulation repeals the requirement for a declination from the State Industrial Insurance System before accessing the residual market, and allows the advisory organization to file special programs under the residual market to meet market needs.

#### NOTICE OF INTENT TO ACT UPON REGULATIONS

Notice of Hearing for the Adoption of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance (Division) will hold a public hearing at 10:00 a.m., on December 1, 1999, immediately following a public workshop, at the offices of the Division, 1665 Hot Springs Road, Suite 152, Carson City, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulations pertaining to service contracts.

#### REGULATIONS FOR SERVICE CONTRACTS

The following information is provided pursuant to the requirements of NRS 233B.060:

- 1. The proposed regulations are needed to establish requirements for the approval and administration of service contracts in response to a new chapter enacted by the 1999 Nevada Legislature (chapter 612, Statutes of Nevada 1999, at page 3335.)
- 2. The proposed regulation establishes the fees and documents that must be submitted with the filing of a service contract, requirements regarding the administration of claims, and the fees applicable to a terminated contract.
- 3. Estimated economic effect of the regulation:
  - On the business which it is to regulate:

The proposed regulation may have both an immediate and long-term impact on providers of service contracts if they are not currently maintaining a toll-free telephone number or if they must implement emergency services.

On the public:

The proposed regulations should have no economic impact on the public.

- 4. The Division expects to incur significant additional expense to enforce the proposed regulations which cannot be measured at this time due to uncertainty regarding the number of approved providers.
- 5. The Division is not aware of any overlap or duplication of the regulation with any state, local or federal regulation.
- 6. The proposed regulation does not establish any new fees or increase an existing fee.

Persons wishing to comment upon the proposed action of the Division may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to the Division, 1665 Hot Springs Road, Suite 152, Carson City, Nevada 89706. Written submissions must be received by the Division on or before November 29, 1999. If no person who is

directly affected by the proposed action appears to request time to make an oral presentation, the Division may proceed immediately to act upon any written submissions.

## PROPOSED REGULATION OF THE DIVISION OF INSURANCE OF THE DEPARTMENT OF BUSINESS AND INDUSTRY

**Regulation Concerning Service Contracts** 

Authority: Section 25 of Chapter 612, Statutes of Nevada 1999, at page 3335 (AB 673).

Section 1. NAC is hereby amended by adding thereto a new chapter to consist of the provisions set forth as sections 2 to 8, inclusive, of this regulation.

Sec. 2. As used in this chapter, unless the context otherwise requires, the words and terms defined in Sections 3 to 9, inclusive, of Assembly Bill 673 have the meanings ascribed to them in those sections.

Sec. 3. Except as provided by specific statute or regulation, a service contract does not include:

- 1. A service contract issued by a motor club, as defined in chapter 696A of NRS.
- 2. A home warranty contract, as identified in sections 100 to 180, inclusive, of chapter 690B of NRS.
  - 3. Contracts of insurance issued by admitted insurers licensed pursuant to Title 57 of NRS.
- Sec. 4. 1. A submission of a service contract must include:
  - (a) All forms to be used with the contract.
  - (b) The commissioner's form for assessing fees and the appropriate filing fee, which are:
- (1) One \$25 fee for any number of filings of fee schedules and of forms for riders and endorsements which are necessary to carry out a new program.
  - (2) A \$25 fee for each contract or fee schedule that modifies an existing program.

- (3) A \$10 fee for each rider or endorsement that modifies an existing program.
- 2. The commissioner shall approve or disapprove each submission no later than 60 days after it is determined by him to be complete pursuant to subsection 1. If the commissioner fails to approve or disapprove the submission within that period, the submission will be deemed approved.
- 3. A provider shall not issue a service contract unless it has been approved by the commissioner.
- Sec. 5. A service contract must clearly state the procedures for making a claim on the contract, including:
  - 1. A toll-free telephone number for claim service.
- 2. Procedures for obtaining prior approval of work if such approval is required by the contract.
- 3. Procedures for obtaining for emergency repairs outside of normal business hours. If the emergency involves the loss of heating or cooling, loss of plumbing, substantial loss of electrical service or any other condition which renders a dwelling uninhabitable, repairs must commence within 24 hours after the report of the claim.
- Sec. 6. Any provision in a service contract that excludes preexisting conditions must specifically state which preexisting conditions are excluded from coverage.
- Sec. 7. 1. In the event the original holder makes a written demand for cancellation of a service contract pursuant to the terms of the contract, the provider shall refund to the holder

the unearned portion of the full purchase price of the contract. Any refund due the holder may be credited to any outstanding balance of the account of the holder, and the excess, if any, shall be refunded to the holder.

- 2. If a holder cancels a service contract pursuant to subsection 1, the provider may impose a reasonable cancellation fee if such a fee is provided for in the contract.
- Sec. 8. Service of process against a provider shall be handled in the manner prescribed in section 260 of chapter 680A of NRS.
