PROPOSED REGULATION OF THE NEVADA HIGHER EDUCATION TUITION TRUST FUND BOARD OF TRUSTEES

NOTICE OF INTENT TO AMEND A REGULATION

Notice of Hearing for the Amendment of Permanent Regulations of the Nevada Prepaid Tuition Program, Nevada State Treasurer's Office.

The Higher Education Tuition Trust Fund Board of Trustees will hold a public hearing on July 6, 2000 at 1:00 p.m. in the Office of the State Treasurer located in the Capitol Building, 101 N. Carson Street, Suite 4, Carson City, Nevada, 89701. The purpose of the hearing is to receive comments from all interested persons regarding the minor amendment to the Regulations for the Nevada Prepaid Tuition Program. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada Higher Education Tuition Trust Fund Board of Trustees may proceed immediately to act upon any written submissions.

The purpose of amending the permanent regulations of the Nevada Prepaid Tuition Program is:

- 1. To provide a two-year university plan, for (4) semesters at a four-year university.
- 2. To allow two contracts per qualified beneficiary as long as the two contracts do not add up to more than 120 semester credit hours.

The purpose of this amendment is to increase contract sales by offering more choices of plans from which purchasers can choose. There will be no economic effect on any businesses, since the Nevada Prepaid Tuition Program is not a regulatory agency. There will be no economic effect on the public, since offering this additional plan will not increase the costs of program administration.

The current, or proposed regulation does not overlap any existing local, state or federal regulation. Federal law does not require this regulation, nor is it more stringent than a federal regulation that regulates any activity connected with the Nevada Prepaid Tuition Program.

This amendment will not result in any new fees, or the increase of any existing fee connected with the administration of the Program.

Persons wishing to comment upon the proposed action of the Nevada Higher Education Tuition Trust Fund Board of Trustees may appear at the scheduled public hearing or may address their comments, data, view or arguments, in written form, to the Nevada Prepaid Tuition Program, 555 E. Washington Avenue, Suite 4600, Las Vegas, Nevada, 89101. Written submission must be received by the Nevada Prepaid Tuition Program on or before June 25, 2000. If no person who is directly affected by the proposed action appears to request time to make an oral

presentation, the Nevada Higher Education Tuition Trust Fund Board of Trustees may proceed immediately to act upon any written submissions.

PROPOSED REGULATION OF THE NEVADA HIGHER EDUCATION TUITION TRUST FUND BOARD OF TRUSTEES

Section 1. NAC 353B.150 Options for institution of higher education; number of semester hours for which contract may be made. (NRS 353B.090)

- 1. A contract may provide for payment from the trust fund of the amount of tuition required for the enrollment of a qualified beneficiary into:
- (a) A state community college in sufficient classes for a student to earn 60 semester hours of credit;
 - (b) A state:
- (1) Community college in sufficient classes for a student to earn 60 semester hours of credit; and
 - (2) University in sufficient classes for a student to earn 60 semester hours of credit; [or]
- (c) A state university in sufficient classes for a student to earn 60 semester hours of credit, or
 - (d) A state university in sufficient classes for a student to earn 120 semester hours of credit.
- 2. As used in this section, "classes" means classes pursuant to which a student may earn an associate's degree in 2 years of study or a bachelor's degree in 4 years of study.

Sec. 2. NAC 353B.160 Restrictions on payment of tuition and other amounts charged for enrollment. (NRS 353B.090) No contract may authorize the payment of:

- 1. Tuition for:
- (a) More than one qualified beneficiary; or
- (b) A person who is designated as a qualified beneficiary for another contract; unless the purchaser selects a two year university plan as defined by NAC 353B.090(c), in which case a second contract may be purchased for the qualified beneficiary as long as no more that 120 semester hours are contracted or
- 2. Except for the amount of tuition authorized pursuant to NAC 353B.150, any other amounts charged for the enrollment of a qualified beneficiary into an eligible school.
