NOTICE OF INTENT TO ACT UPON A REGULATION

**Notice of Workshop and Hearing for the Adoption, Amendment or Repeal of Regulations
Of
The State of Nevada Commission on Construction Education**

The State of Nevada Commission on Construction Education will hold a workshop and public hearing at the State Contractors Board's Henderson Office at 2310 Corporate Circle, Suite 200, Henderson, Nevada 89074 on Tuesday, March 12, 2002. The workshop will begin at 9:00 a.m. The hearing will commence upon conclusion of the workshop. The purpose of the workshop and hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of regulations that pertain to Chapter 624 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.060 and 233B.0603:

1. The need for and purpose of the proposed regulation or amendment.

Pursuant to NRS 624.570(5) the Commission shall adopt regulations providing procedures for applying for a grant from the construction education account; procedures for reviewing an application for a grant; and qualifications for receiving a grant from the construction education account.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed or a description of the subjects and issues involved.

The proposed regulation sets forth the procedures for applying for a grant, reviewing an application for a grant and the qualifications for receiving a grant from the construction education account. A copy of the proposed regulation may be obtained by writing to the Commission on Construction Education c/o the State Contractors Board, 9670 Gateway Drive, Reno, Nevada 89511.

3. The estimated economic effect of this proposed regulation on the business which it is to regulate and on the public.

If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Commission may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be adopted, amended or repealed will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notices and the regulation to be adopted will be available at the Commission on Construction Education c/o State Contractors Board, 9670 Gateway Drive, Suite 100, Reno, Nevada 89511. A copy of this notice and the text of the proposed regulation will also be available for public inspection and copying at the public library of each county during business hours. This notice and the text of the proposed regulation will be available in the State of Nevada Register of Administrative Regulations which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at <http://www.leg.state.nv.us>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the Commission, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

**PROPOSED REGULATION OF THE COMMISSION
ON CONSTRUCTION EDUCATION**

GRANT APPLICATIONS

Section 1. *Chapter 624 of NAC is hereby amended by adding thereto the provisions set forth as section 2.*

Sec. 2. *An application for a grant of money from the construction education account must be on a form provided by the commission and contain:*

- 1. Applicant's full name, address and telephone number.*
- 2. Documentation that the applicant is enrolled in a program for construction education that has been approved by the commission.*
- 3. Any other documentation required by the commission.*
- 4. Applications must be notarized.*
