

**ADOPTED REGULATION OF THE DEPARTMENT
OF MOTOR VEHICLES**

LCB File No. R083-03

Effective October 30, 2003

EXPLANATION – Matter in *italics* is new; matter in brackets ~~omitted material~~ is material to be omitted.

AUTHORITY: §1, NRS 483.220 and 483.247.

Section 1. NAC 483.1982 is hereby amended to read as follows:

483.1982 An international instructor or international student who applies for an original driver's license or instruction permit or for the renewal or extension of a driver's license or instruction permit must provide with his application:

1. If he is an international instructor, a letter, signed by the administrator of the educational institution *located in this state* at which he is an instructor, dated not earlier than 30 days before receipt of the application by the Department, as proof that he is an international instructor. The letter must include, without limitation:

- (a) The date of his employment;
- (b) A statement that indicates that the applicant is an instructor at the educational institution;

and

(c) A statement that indicates that his employment with the educational institution is indefinite.

2. If he is an international student, a letter, signed by the administrator of the educational institution *located in this state* at which he is a student, dated not earlier than 30 days before

receipt of the application by the Department, as proof that he is an international student. The letter must include, without limitation:

- (a) The date of his enrollment;
- (b) A statement that indicates that the applicant is a student at the educational institution; and
- (c) A statement that indicates that his enrollment at the educational institution is indefinite.

3. Any other information or documentation requested by the Department, which may include, without limitation:

- (a) An identification card issued by the educational institution, including, without limitation:
 - (1) An identification card for members of the staff or faculty; and
 - (2) An identification card for students;
- (b) His school transcript; and
- (c) His enrollment records.

INFORMATIONAL STATEMENT

The Department of Motor Vehicles noticed and held public workshops and public hearings on September 11 and September 12, 2003, in Reno and Las Vegas, respectively, to solicit comments and opinion on proposed regulations to specify that the educational institution an international student or instructor is attending or employed must be located in Nevada. Copies of the proposed regulations were available by contacting the Department at (775) 684-4778 or through the mail, 555 Wright Way, Carson City, Nevada 89711.

The notice of public workshops and hearings and complete copies of the proposed regulations were posted on or before July 24, 2003, at the Nevada State Library and Archives and each office of the Department of Motor Vehicles. In each county where the Department does not maintain an office, the notice was posted at the main office of the public library.

Public workshops and hearings were held at 10:00 a.m. on September 11, 2003 in Reno and at 10:00 a.m. on September 12, 2003 in Las Vegas; no one was in attendance at either location and no testimony concerning the proposed regulation was taken. No written comments were received.

The Department will adopt the proposed regulations with no changes made.

There are no adverse economic effects of this regulation to the Department, local authorities or the public.

There are no other state or government regulations that the proposed regulations duplicate.
