

**ADOPTED REGULATION OF THE DEPARTMENT  
OF MOTOR VEHICLES**

Effective December 4, 2003

AUTHORITY: §1, NRS 482.399.

**Section 1.** Chapter 482 of NAC is hereby amended by adding thereto a new section to read as follows:

*For the purpose of paragraph (b) of subsection 9 of NRS 482.399, a vehicle shall be deemed to be inoperable if the vehicle:*

- 1. Is of a type that is subject to registration pursuant to chapter 482 of NRS;*
- 2. Has been wrecked, destroyed or otherwise damaged to the extent that the owner, leasing company, financial institution or insurance company that insured the vehicle has determined that repairing the vehicle is uneconomical; and*
- 3. Because of the wreckage, destruction or other damage specified in subsection 2, is not repaired by or for the person who owned the vehicle at the time the vehicle was wrecked, destroyed or damaged.*

**INFORMATIONAL STATEMENT**

**The following statement is submitted for adopted amendments to Nevada Administrative Code, Chapter 482.**

The Department of Motor Vehicles noticed and held public workshops and public hearings on September 11 and September 12, 2003, in Reno and Las Vegas, respectively, to solicit comments and opinion on proposed regulation changes required by Assembly Bill 30 passed during the 2003 Legislative Session. Copies of the proposed regulations were available by contacting the Department at (775) 684-4783 or through the mail, 555 Wright Way, Carson City, Nevada 89711.

The notice of public workshops and hearings and complete copies of the proposed regulations were posted on or before July 24, 2003, at the Nevada State Library and Archives and each office of the Department of Motor Vehicles. In each county where the Department does not maintain an office, the notice was posted at the main office of the public library.

Public workshops and hearings were held at 10:00 a.m. on September 11, 2003 in Reno and at 10:00 a.m. on September 12, 2003 in Las Vegas; no one was in attendance at either location and no testimony concerning the proposed regulations was taken. No written comments were received.

The Department will adopt the proposed regulations with no changes made.

There are no adverse economic effects of this regulation to the Department, local authorities or the public.

There are no other state or government regulations that the proposed regulations duplicate.
