

**ADOPTED REGULATION OF THE COMMISSION ON
PROFESSIONAL STANDARDS IN EDUCATION**

LCB File No. R222-05

Effective February 23, 2006

A REGULATION relating to educational personnel; revising provisions governing the majors and minors in academic education to include dance; and providing other matters properly relating thereto.

Section 1. NAC 391.131 is hereby amended to read as follows:

391.131 1. The Board recognizes the following single subjects in academic education as majors or minors, which require 30 or 16 semester hours of credit respectively:

Sec. 2. NAC 391.1312 is hereby amended to read as follows:

391.1312 1. The semester hours of credit required for a major listed in subparagraphs (1) to (9), inclusive, of paragraph ~~[(4)]~~ *(m)* of subsection 1 of NAC 391.131 and paragraph ~~[(z)]~~ *(aa)* of subsection 1 of NAC 391.131 must include 15 semester hours in courses normally given to juniors or seniors.

2. The semester hours of credit required for a minor listed in the paragraphs identified in subsection 1 must include 5 semester hours in courses normally given to juniors or seniors.

3. The semester hours of credit required for a major listed in subparagraphs (1) to (9), inclusive, of paragraph ~~[(4)]~~ *(m)* of subsection 1 of NAC 391.131 and paragraphs ~~[(t) and (z)]~~ *(u)* **and** *(aa)* of subsection 1 of NAC 391.131 must not include any semester hours in freshman English. Eighteen of the semester hours must be in courses normally given to juniors or seniors.

4. The semester hours of credit required for a minor in reading must not include any semester hours in freshman English. Nine of the semester hours of credit must be in courses normally given to juniors or seniors.

INFORMATIONAL STATEMENT

1. A description of how public comment was solicited, a summary of public response, and explanation how other interested persons may obtain a copy of the summary.

Notice of Workshop to Solicit Comments on Proposed Regulations was sent to approximately 100 individuals and educational organizations. A workshop was held on December 16, 2005. There was public comment.

The Notice of Intent to Act Upon a Regulation for public hearing and adoption of the amendments to NAC 391.131 – Single-Subject Major and Minor; and NAC 391.1312 – Restrictions on Hours of Credit for Certain Subjects was sent to approximately 100 individuals and educational organizations. The public hearing was conducted on February 2, 2006 to provide the opportunity for comments by affected parties and the public. There was no public comment. The Commission adopted the proposed amendments to the regulation.

3. A description of how comment was solicited from affected businesses, a summary of the response and an explanation how other interested parties may obtain a copy of the summary.

Comments were solicited through the workshop notice of November 9, 2005; and the public hearing notice of December 27, 2005. At the December 16, 2005 Workshop to Solicit Comments, there were public comments to the proposed amendments to the regulation language. At the February 2, 2006 Public Hearing there was no public comment to the proposed amendments to the regulation language.

Summary of Comments:

Workshop/Public Hearing Comments:

- (a) Mary Ann Gibbs, Clark County School District, stated that a teacher with a physical education license can teach PE, but an individual with a major in dance cannot teach dance, as there is no dance license.

The Commission on Professional Standards in Public Education adopted the proposed amendments to the regulation language at the public hearing held February 2, 2006. The reason for adopting the regulation is to allow an individual with a degree in dance to be able to obtain a teaching license to teach dance in the schools.

5. The estimated economic effect of the adopted regulation on the business that it is to regulate and on the public. These must be stated separately and each case must include:

The beneficial economic effect is that it would allow school districts to hire an individual qualified to teach dance with a degree in dance. There is no estimated economic effect on the public, either adversely or beneficially, nor immediate or long term.

There is no additional cost to the agency for enforcement of this regulation.
