PROPOSED REGULATION OF THE COMMISSIONER OF INSURANCE

AMENDED NOTICE OF WORKSHOPS TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The Department of Business and Industry, Division of Insurance (Division), is proposing new regulations pertaining to current costs of certain publications, special deposits for insurers of workers' compensation, and examiner rates as published by the NAIC. A workshop has been set for **9:00 a.m., on May 4, 2006**, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested parties may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Manufactured Housing Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics addressed in the proposed regulations.

- 1. <u>Update Current Costs of Certain Publications</u>. NAC 616B.427 and NAC 616B.606 are amended to update the current costs of certain publications cited in those regulations.
- 2. <u>Establishing Special Deposits for Insurers of Workers' Compensation</u>. NAC 682B.020 is amended to establish special deposits for insurers of workers' compensation. The proposal will increase the amount of the deposit most insurers presently have pledged for benefit of this State for the benefit of claimants of insolvent insurers of workers' compensation policies in the future.
- 3. Remove Reference to Examiner Rates as Published by the NAIC. NAC 679B.0335 is amended to remove reference to examiner rates as published by the National Association of Insurance Commissioners (NAIC). The proposed amendment to NAC 679B.0335 eliminates the reference to posted NAIC rates for examiner compensation. The purpose of removing the reference to examiner rates as published by the NAIC will provide greater latitude in procuring well qualified, competent contract examiner resources.

NAC 616B.606 references publications available for purchase from the National Association of Insurance Commissioners. This regulation includes the cost of each item and the location where it can be obtained. This amendment will provide the current cost of those publications.

PROPOSED AMENDMENT TO UPDATE COSTS IN THE REGULATION FOR GOVERNMENTAL EMPLOYER: QUALIFICATION AS SELF-INSURED EMPLOYER:

PROPOSED AMENDMENT TO UPDATE COSTS IN THE REGULATION FOR ADOPTION BY REFERENCE OF CERTAIN PUBLICATIONS

AUTHORITY: NRS 679B.130

Section 1. NAC 616B.427 is hereby amended to read as follows:

616B.427 1. To determine whether a governmental employer had the financial ability to qualify as

a self-insured employer, the Commissioner will consider the use of fund accounting and waive the

requirement for a tangible net worth found in NAC 616B.424. All other requirements for

qualification apply to the governmental entity.

2. In addition to the deposit required by NRS 616B.300, a governmental entity that does not meet

the requirements of subsection 1, shall:

a) Comply with the requirements of Statement No. 10 of the Governmental Accounting Standards

Board, which may be obtained from the Governmental Accounting Standards Board, P.O. Box

30784, Hartford, Connecticut 06150, at a cost of [\$5.50] \$16.25 or

b) Set aside, in a special reserve account, an amount equal to the deposit it made with the

Commissioner to assure payment of claims. This account must be held in trust for the payment of

claims and all interest and income earned must be credited to that fund. If securities are used for this

account, then the form of the securities must be submitted to the Commissioner for his approval.

Sec. 2. NAC 616B.606 is hereby amended to read as follows:
