PROPOSED REGULATION OF THE COMMISSIONER OF INSURANCE

NOTICE OF WORKSHOPS TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The Department of Business and Industry, Division of Insurance (Division), is proposing new regulations pertaining to rate service organizations and lost cost adoption; use of chargeable accidents and proposed repeal of Nevada Administrative Code (NAC) 690B.230; and repeal of certain regulations concerning company rate and form filing requirements. A workshop has been set for **9:00 a.m., on May 25, 2006**, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested parties may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Manufactured Housing Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics addressed in the proposed regulations:

- 1. Rate Service Organizations and Loss Cost Adoption. The proposed amendments to Chapter 686B of the NAC provide that rate service organizations shall be examined at intervals not less than 5 years. Also clarified is that insurers underwriting policies of industrial insurance (workers' compensation) must use the current approved loss costs filed by the advisory organization. Some insurers may have been confused by the language in NAC 686B.460 which was never intended to apply to policies of industrial insurance.
- 2. <u>Use of Chargeable Accidents and Proposed Repeal of NAC 690B.230</u>. The proposed amendment to Chapter 687B of the NAC clarifies that insurers cannot use non-chargeable accidents in rating, cancellation or non-renewal of a private passenger auto policy. Also, proposed repeal of NAC 690B.230.
- 3. Repeal of Certain Publications Concerning Company Rate and Form Filing Requirements. Repeal of NAC 680B.060 which allows an insurer to submit one rate and form filing on behalf of a group of insurers rather than submitting one rate and form filing for each insurer. Repeal of NAC 680B.080 which requires surplus lines carriers to pay certain filing fees to the Division.

Notice of Hearing for the Adoption of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance (Division), will hold a public hearing at **9:00 a.m., on May 25, 2006,** immediately following a public workshop, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested persons may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Manufactured Housing Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of:

PROPOSED REGULATION CONCERNING USE OF CHARGEABLE ACCIDENTS and PROPOSED REPEAL OF NAC 690B.230

1. A statement of the need for and purpose of the proposed regulation:

This proposed regulation eliminates conflict with NRS 687B.385 regarding the consideration of comprehensive claims as chargeable accidents. Under NRS 687B.385, "an insurer shall not cancel, refuse to renew or increase the premium for renewal of a policy of motor vehicle insurance covering private passenger cars or commercial vehicles as a result of any claims made under the policy with respect to which the insured was not at fault." There is no fault assigned to comprehensive claims and, therefore, under NRS 687B.385, comprehensive claims cannot be considered chargeable accidents. This proposed regulation narrows the scope of application to existing business since NRS 687B.385 applies to existing business only.

2. Either the terms or substance of the proposed regulation or a description of the subjects and issues involved:

This amendment clarifies that insurers cannot use non-chargeable accidents in rating, cancellation or non-renewal of a private passenger auto policy.

- 3. Estimated economic effect of the regulation:
 - (1) Both adverse and beneficial effects: Individuals or businesses with a series of comprehensive claims will not be allowed to be surcharged for these claims and will benefit. This change may have some short-term economic impact on insurers as some insurers may have to adjust their rating algorithms. It is not possible to quantify these impacts.
 - (II) Both immediate and long-term effects: Lower rates for some consumers.

4. A statement identifying the methods used by the agency in determining the impact on a small business prepared pursuant to subsection 3 of NRS 233B.0608:

Elimination of the conflict is not expected to have any significant impact on small businesses.

5. The estimated cost to the agency for enforcement of the proposed regulation:

Enforcement of the regulation could be accomplished through market conduct examinations that are routinely scheduled by the Division.

6. PROPOSED REGULATION OF THE COMMISSIONER OF INSURANCE

PROPOSED REGULATION CONCERNING USE OF CHARGEABLE ACCIDENTS and PROPOSED REPEAL OF NAC 690B.230

AUTHORITY: NRS 679B.130

A REGULATION relating to the use of chargeable accidents in underwriting and rating motor vehicle insurance policies.

Section 1. Chapter 687B of NAC is hereby amended by adding thereto the provisions set forth as section 2 of this regulation.

Sec. 2. 1. An insurer shall not use a non-chargeable accident to cancel, refuse to renew or increase the premium upon renewal of a policy of motor vehicle insurance.

- 2. Each insurer shall file with the Division its definition of a "chargeable accident" and shall use the filed definition. The insurer's definition of a "chargeable accident" may include only those accidents for which the insured is 50 percent or more at fault.
- 3. Each filing of a rate for insurance for automobiles submitted to the Division must define a "chargeable accident" in terms of a monetary amount of damage.
- **Sec. 3.** NAC 690B.230 is hereby repealed.
