**PROPOSED REGULATION OF THE
COMMISSIONER OF INSURANCE**

**NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON
PROPOSED REGULATIONS**

The Department of Business and Industry, Division of Insurance (Division), (775) 687-4270, is proposing the amendment of regulations pertaining to **chapters 616B, 680B, and 694C** of the Nevada Administrative Code (NAC). **A workshop has been set for 9:00 a.m., on November 27, 2007, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701.** Interested parties may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Real Estate Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations.

Examination Rates and Expenses re: Captive Insurers. This proposed regulation amending chapter 694C of the NAC authorizes the Commissioner to set examination expenses, specifically for captive insurance companies, incurred by a financial or market conduct examiner. At this time, there are no examination expense guidelines specifically for captive insurance companies.

Cash Flow Evaluation. The proposed regulation amending NAC 616B.433 clarifies what items are not allowed to be considered when determining the tangible net worth of a self-insured employer. This amendment also explains what a self-insured employer must submit to the Division to qualify for a cash flow evaluation of the association's solvency. The proposed regulation amends chapter 616B of the NAC by adding thereto a new section explaining what a self-insured association must submit to the Division to qualify for a cash flow evaluation of the association's solvency.

Consent to Rate. The proposed regulation amends NAC 680B.040 to be consistent with NAC 686B.520, which was amended on May 24, 2005, to require a formal rate filing for each consent to rate filing when a deviation from an insurer's filed rates is for either a higher or lower rate. Currently, NAC 680B.040 addresses only the circumstance of a higher rate.

NOTICE OF INTENT TO ACT UPON REGULATION

Notice of Hearing for the Amendment of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance (Division), will hold a public hearing at **9:00 a.m., on November 28, 2007, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701.** Interested persons may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Real Estate Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of the regulation that pertains to **chapter 694C** of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment.

This regulation authorizes the Commissioner to set examination expenses, specifically for captive insurance companies, incurred by a financial or market conduct examiner. At this time, there are no examination expense guidelines specifically for captive insurance companies.

2. Either the terms or substance of the regulation to be adopted, amended, or repealed, or a description of the subjects and issues involved.

The examiner will follow expense guidelines as outlined in the Examiners Handbook published by the National Association of Insurance Commissioners.

3. The estimated economic effect of the regulation on the business that it is to regulate and on the public. These must be stated separately and in each case must include:

- (a) Both adverse and beneficial effects:

Each captive insurance company will have to pay for the cost of the exam just as other insurance companies licensed in Nevada are required to pay for their examinations. The benefit allows the Division to verify the captive is in compliance with Nevada laws and its business plan. There is no adverse effect.

- (b) Both immediate and long-term effects:

The captive will pay for the examination expenses in the short run and the long run.

4. The estimated cost to the agency for the enforcement of the proposed regulation.

The examinations are conducted by outside contract examiners.

5. A description of and citation to any regulations of other state or local governmental agencies that the proposed regulation overlaps or duplicates, and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.

6. If the regulation is required pursuant to federal law, a citation and description of the federal law.

8. Whether the proposed regulation establishes a new fee or increases an existing fee.

There is no new fee created or increase in fees contemplated or expected as a result of this regulation.

9. A statement identifying the methods used by the agency in determining the impact on a small business prepared pursuant to subsection 3 of NRS 233B.0608.

There is no direct or significant economic burden on captives regarding this regulation and, in fact, it clarifies the expense scope and range a captive can be expected to pay for an examination.

Persons wishing to comment upon the proposed action of the Division may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. **Written submissions must be received by the Division on or before November 20, 2007.** If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Division may proceed immediately to act upon any written submissions.

**PROPOSED REGULATION OF THE

**PROPOSED REGULATION OUTLINING THE EXAMINATION RATES AND EXPENSES
FOLLOWED BY EXAMINERS OF CAPTIVE INSURERS**

AUTHORITY: NRS 679B.130.

Section 1. Chapter 694C of NAC is hereby amended by adding thereto a new section to read as follows:

Sec. 2. *Reasonable and proper expenses incurred in an examination conducted pursuant to NRS 694C.410 and 694C.415 may include, but are not limited to:*

a. For a financial examiner or market conduct examiner, a daily salary as defined in the Examiners Handbook published by the National Association of Insurance Commissioners, which has been adopted by reference in NAC 679B.033.

b. For expert assistants, a daily salary based upon the rate established in the contract approved by the State Board of Examiners.

c. The maximum per diem rate for the location of the examination as set forth by the U. S. General Services Administration available for viewing at the following Web site:

http://www.gsa.gov/Portal/gsa/ep/contentView.do?contentId=17943&contentType=GSA_BASIC

d. Expenses for transportation, including, but not limited to, the cost of airfare, rail fare, taxicab fare and automobile rental and the reimbursement of any reasonable personal automobile expenses necessary to reach the location of the examination. The calculation of expenses for transportation may include expenses for transportation incurred by virtue of the length of time necessary to complete the examination.

e. Upon approval of the Commissioner, miscellaneous expenses incurred by the examiner and assistants while performing an examination. Miscellaneous expenses may include, but are not limited to, expenses for telephone calls, facsimile transmissions and postal charges relating to the examination.

f. An administrative charge, expressed as a percentage of the daily salary of the examiner or assistant, as provided in subsections (a) and (b) of this section and as provided in the division budget approved by the Nevada Legislature.
