

**ADOPTED REGULATION OF
THE BOARD OF ATHLETIC TRAINERS**

LCB File No. R106-07

Effective January 30, 2008

AUTHORITY: §§1-5 and 7, NRS 640B.260; §6, NRS 353C.115, 640B.250, 640B.260 and 640B.410.

A REGULATION relating to athletic trainers; prescribing the amount of fees pertaining to licensing of athletic trainers; and providing other matters properly relating thereto.

Section 1. Chapter 640B of NAC is hereby amended by adding thereto the provisions set forth as sections 2 to 6, inclusive, of this regulation.

Sec. 2. *As used in this chapter, unless the context otherwise requires, the words and terms defined in NAC 640B.010 and sections 3 and 4 of this regulation have the meanings ascribed to them in those sections.*

Sec. 3. *“License” means a license to engage in the practice of athletic training issued pursuant to chapter 640B of NRS.*

Sec. 4. *“Licensee” means a person who has been issued a license pursuant to chapter 640B of NRS.*

Sec. 5. *All items required by NRS 640B.340 and 640B.400 for the renewal of a license must be received by the Board, or postmarked, not later than June 30 of each year. If the Board does not receive the items, or if the items are not postmarked, on or before June 30, the license expires.*

Sec. 6. 1. *The Board will charge and collect the following fees:*

For an initial application for a license \$300

For the renewal of a license 150

For the restoration of an expired license 300

For the issuance of a duplicate license 25

For a change of name on a license 25

For a list of business addresses of licensees 25

For a list of business addresses of licensees on mailing labels 100

For a dishonored check 25

2. A fee charged and collected pursuant to this section:

- (a) Must accompany the application or other documentation to which the fee pertains; and*
- (b) Is not refundable.*

Sec. 7. NAC 640B.010 is hereby amended to read as follows:

640B.010 ~~[As used in this chapter, unless the context otherwise requires,]~~ “Board” means the Board of Athletic Trainers.

**NOTICE OF ADOPTION OF PROPOSED REGULATION
LCB File No. R106-07**

The Board of Athletic Trainers adopted regulations assigned LCB File No. R106-07 which pertain to chapter 640B of the Nevada Administrative Code.

INFORMATIONAL STATEMENT

1. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Public comment was solicited at a workshop held August 07, 2007. The Nevada State Board of Athletic Trainers held a public hearing at 9:00am. on December 04, 2007 at University of Nevada, 1664 N. Virginia St., Savitt Medical Science Building, Jones Conference Room #124, Reno, NV 89557 and at University of Nevada Las Vegas, 4505 Maryland Parkway, College of Education Building, Room #216, Las Vegas, NV 89154 to review the regulation to specify fee requirements for the licensing of athletic trainers. There were no members of the public present at the public hearing.

The purpose of the hearing was to receive comments from all interested persons regarding the adoption of regulations that pertain to chapter **640B** of the Nevada Administrative Code.

A copy of this notice and the regulation to be adopted were on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be adopted were made available at: The Nevada State Board of Athletic Trainers, P.O. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary. This does not apply to a public body subject to the Open Meeting Law.

The hearing was attended by four (4) board members and the Executive Secretary of the Board. There were no members of the public present. There were no written comments submitted to the agency.

Box 34296, Reno, NV 89533-4296. Written submissions must be received by the Nevada State Board of Athletic Trainers on or before December 04, 2007 at 9:00am. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Athletic Trainers may proceed immediately to act upon any written submissions. There were no responses received from affected businesses.

4. **If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.**

The regulation was adopted at the Nevada State Board of Athletic Trainers hearing on December 04, 2007 with no changes made to the proposed regulation (LCB File No. R106-07).

This regulation will generate funds to operate the Nevada State Board of Athletic Trainers. There will be no economic impact on businesses or the public.
