PROPOSED REGULATION OF THE DIRECTOR OF THE STATE DEPARTMENT OF AGRICULTURE

This change has been requested by federal agencies that have recently purchased seed for rehabilitation projects and later found it to be infested with noxious weed seed from weed species not currently listed in NAC 587.173 or NAC587.175.

Nevada Noxious Weeds currently on the **Prohibited noxious weed seeds** list would be deleted since they would be added back to that list by reference. Similarly, puncture vine (*Tribulus terrestris*) would be deleted from NAC 587.175 since it would be added the **Prohibited noxious weed seeds** list by reference.

New text is in *italics*. Deleted text is ~~crossed-out~~.

NAC 587.173 Prohibited noxious weed seeds. (NRS 587.083) Seed of the following plants are classified as prohibited noxious weed seeds, the occurrence of which must not exceed the tolerances prescribed by NAC 587.200:

1. The state noxious weed list species NAC 555.010 are hereby included by reference.

NAC 587.175 Restricted noxious weed seeds. (NRS 587.083) Seed of the following plants are restricted noxious weed seeds, the occurrence of which must not exceed 27 per pound, singly or collectively:

1. Bindweed, field (*Convolvulus arvensis*).
2. Crabgrass (*Digitaria sanguinalis*, *Digitaria ischaemum*).
3. Dock, curly (*Rumex crispus*).
4. Dodder, all species (*Cuscuta* spp.).
5. Mustard, wild (Charlock) (*Brassica kaber*).
6. Pennycress (Fanweed) (*Thlaspi arvense*).
