# **NOTICE OF INTENT TO ACT UPON A REGULATION**

Notice of Hearing for the Adoption, Amendment and Repeal of Regulations of the Nevada State Board of Cosmetology

The Nevada State Board of Cosmetology will hold a public hearing at 9:00 a.m., on May 5, 2008, at 1785 E. Sahara Ave., Suite 255, Las Vegas, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the adoption, amendment and repeal of regulations that pertain to chapter 644 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

To protect the health and safety of the public through the proper regulation of: schools of cosmetology, curriculum, equipment, and facilities; cosmetological establishments, licensing, facilities, and equipment; licensing of individual practitioners, facilities, and equipment by bringing requirements to current standards within the industry and better protect the public's health and safety.
