**NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON

The Department of Business and Industry, Division of Insurance (Division), (775) 687-4270, is proposing the amendment of regulations pertaining to **chapter 616B** of the Nevada Administrative Code (NAC). A workshop has been set for **9:00 a.m. on May 20, 2008**, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested parties may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Real Estate Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations.

The purpose of the amendments to NAC 616B.427 is to update the current costs of certain publications cited in those regulations.

NOTICE OF INTENT TO ACT UPON REGULATION

Notice of Hearing for the Amendment of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance (Division), will hold a public hearing at **9:00 a.m. on May 27, 2008**, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested persons may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Real Estate Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of the regulation that pertains to **chapter 616B** of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of NRS 233B.0603:

REGULATION CONCERNING AMENDMENTS TO NAC 616B.427 TO UPDATE COSTS OF CERTAIN PUBLICATIONS

1. The need for and the purpose of the proposed regulation or amendment.

NAC 616B.427 identifies requirements for qualifying as a self-insured employer and references to compliance with Statement No. 10 of the Governmental Accounting Standards Board. This regulation includes the cost and the location where the Statement may be obtained. This amendment will provide the current cost of Statement 10.
