NOTICE OF INTENT TO ACT UPON REGULATION

Notice of Hearing for the Amendment and Adoption of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance ("Division"), hereby provides notice that the public hearing for the Model Audit Rule regulation set forth below, originally scheduled for 9:00 a.m. on November 21, 2008, has been **rescheduled to 9:00 a.m. on December 15, 2008,** at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested persons may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Real Estate Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the amendment and adoption of regulations pertaining to **chapter 680A** of the Nevada Administrative Code ("NAC").¹

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment.

NAC 680A is being amended in order for the Division of Insurance to meet the Financial Regulation Standards and Accreditation Program of the National Association of Insurance Commissioners (NAIC). NAIC provides a service to the regulators of every state by drafting Model Laws and Regulations, which are reflective of the changing environment of insurance regulation. As part of a unified coalition of insurance regulators, the various states adopt the NAIC supplied laws and regulations in order to maintain accredited authority to regulate insurance. The proposed amendments are required to be in place as of 1/1/2010.

2. Either the terms or substance of the regulation to be adopted, amended or repealed, or a description of the subject and issues involved.

The proposed and amended regulations are reflective of the provisions of the Sarbanes-Oxley Act of 2002 and the Securities Exchange Act of 1934. The relevant provisions of the Acts address the requirements for insurance companies and related industry to comply with issues

relevant to establishing or strengthening the insurers' internal controls over financial reporting and auditor/accountant independence, as well as requirements relevant to establishing independent Audit committees in insurance companies. All parts are reactive to the meltdown of several large non-insurance companies, in addition to the reliance placed on auditors to certify a company's financial condition.

3. A statement of the estimated economic effect of the regulation on the business it is to regulate and on the public, as follows:

Both adverse and beneficial effects:

The proposed changes should have minimal adverse effect on the regulated insurers. A majority of the requested changes would only have an effect on large insurers and, for the most part, these companies have already had to address these issues due to their structure, size, affiliation, or investment portfolio. The public would not see any effect as the additional processes are additional steps in a standard accounting process.

The proposed amendments ought to increase the public's faith in the insurer's financial condition and strength knowing that the audited reports of the insurer's financial condition are being reviewed more thoroughly and the insurers are being held to a higher standard of accounting/auditing practices and procedures.

Both long-term and immediate effects:

The proposed changes will, over time, increase the public and regulatory community belief that the assertions of insurers are founded and supported by appropriate internal and external accounting and auditing programs.

There most likely will not be an immediate effect on the companies. There is a transition program for companies allowing them to implement the changes over time. The companies will be subject to the additional procedures as of 1/1/2010.

4. The estimated cost to the agency for enforcement of the proposed regulation:

Minimal. The domestic insurer is already subject to the Division's oversight and internal audits through the regulations that are being amended. The proposed changes will be incorporated into existing regulations and into the internal auditing process of the Division. The same is true for the examinations and external audits of the companies. These audits are conducted by the Division with the insurer carrying the cost of the exam. The amendments will be incorporated into the already existing program.

5. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates, and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.

None. Insurance is regulated specifically by the State of Nevada Division of Insurance.

6. If the regulation is required pursuant to federal law, a citation and description of the federal law.

None.

7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions.

None.

8. A statement indicating whether the proposed regulation establishes a new fee or increases an existing fee.

None.

9. A statement identifying the methods used by the agency in determining the impact on a small business prepared pursuant to subsection 3 of NRS 233B.0608.

A small business (insurer) is not required to adhere to the additional requirements of this proposed regulation. The additional requirements of the proposed regulation are to be implemented as the insurer's volume of premium increases. The premium volume has to exceed \$300,000,000 for the majority of the requirements to take effect. The majority of the insurers in Nevada will not reach that high of a premium volume.

Persons wishing to comment upon the proposed action of the Division may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Written submissions must be received by the Division on or before December 8, 2008. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Division may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be adopted will be available at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701, and 2501 East Sahara Avenue, Suite 302, Las Vegas, Nevada 89104, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the **State of Nevada Register of Administrative Regulations**, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653 and on the Internet at **http://www.leg.state.nv.us**. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary. This does not apply to a public body subject to the Open Meeting Law.

Upon adoption of any regulation, the agency, if requested to do so by an interested person,

either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption, and incorporate therein its reason for overruling the consideration urged against its adoption.
