The purpose of the workshop is to solicit comments from interested persons on the following general topics that will be addressed in the proposed regulations. Items will be discussed in the order listed:

Proposed Regulation of the Department of Motor Vehicles

A regulation relating to the Department of Motor Vehicles requiring the validation of current liability insurance coverage for each vehicle actively registered in Nevada. The proposed amendments revise the reporting requirements for insurance companies. Insurance companies will have several methods for reporting, each with specific data requirements. The proposed amendments describe the responsibilities for registered owners to ensure their insurance record is current with the Department of Motor Vehicles.
