**The purpose of the workshop is to solicit comments from interested persons on the following topics that may be addresses in the proposed regulations:**

The following information is provided pursuant to the requirements of NRS 233B.0603:

The Nevada Rehabilitation Division is proposing to amend NAC 426 regulations by adopting/amending the following regulations:

1. NAC 426.015 “Accessories” definition, revised from \$100 to \$500 purchase price and adding small appliances and signage
2. NAC 426.290 Payments for obligations; regulation is to be repealed
3. NAC 426.383 Retirement income benefit for operators, revised to pay not more than \$7000 annually as a retirement income benefit
4. NAC 426 Reimbursement of operators for health insurance, add Bureau to make available no more than \$1000 annually to reimburse each operator for the purchase of life insurance pending approval by the Nevada Committee of Blind Vendors and if the Legislature appropriates money for such a purpose.

5. NAC 426.387 Reimbursement of operators for health care costs, revised to pay not more than \$12,500 annually for reimbursement of health care costs not paid by a third-party insurer
6. NAC 426.220, NAC 426.230, NAC 425.235, NAC 426.245, NAC 426.267, NAC 426.300, NAC 426.383, these regulations were amended by changing the term: “Business Enterprise Account for the Blind” to “Business Enterprise Account for Persons Who Are Blind.”
