**Notice of Hearing for the Amendment  
of Regulations of the

The Nevada Department of Agriculture will hold a public hearing at **3:00 pm., on December 5, 2011**, at Department of Agriculture Headquarters, 405 South 21<sup>st</sup> Street, Sparks, NV 89431; Phone: (775) 353-3601. The purpose of the hearing is to solicit public comment from all interested persons regarding the Amendment of regulations that pertain to chapter 565 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

The purpose of the proposed amendment to NAC 565.230 is to benefit industry by reducing fees charged when staff is administering inspections. Industry has voiced concern regarding the fees that are charged if the regulations are not changed.

The immediate and long-term effect will be reduced cost to the producers and industry.

There will be no additional cost to the Nevada Department of Agriculture for enforcement of the proposed regulation.

The proposed regulation will not overlap or duplicate any regulations set by federal, state or local governmental agencies.

The proposed regulation is not required by federal law.

The proposed regulation does not include any provisions more stringent than a federal regulation that regulates the same activity.

The proposed regulation does reduce an existing fee.
