NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The State of Nevada, Department of Business and Industry, Division of Insurance ("Division"), (775) 687-0700, is proposing the adoption, amendment or repeal of regulations pertaining to chapters 679B, 680A, 681A, 683A, 685A, 690B and 697 of the Nevada Administrative Code ("NAC"). A workshop has been set for **9:00 a.m., on August 1, 2012**, at the Division's office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706. Interested parties may also participate through a simultaneous videoconference conducted at the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations. Please submit any written comments no later than **July 25, 2012**.

LCB File No. R108-10. Prelicensing Exemption.

A regulation relating to insurance; revising provisions relating to prelicensing requirements for persons involved in the sale or administration of insurance; and providing other matters properly relating thereto.

LCB File No. R109-10. Bail Employees.

A regulation relating to bail bond agents; revising the reference to the form for furnishing certain information concerning employees to the Commissioner of Insurance; and providing other matters properly relating thereto.

LCB File No. R110-10. Intermediary Licenses.

A regulation relating to insurance; revising provisions relating to the process for renewing intermediary licenses; and providing other matters properly relating thereto.

NOTICE OF INTENT TO ACT UPON REGULATION

Notice of Hearing for the Adoption, Amendment or Repeal of Regulations of The Department of Business and Industry, Division of Insurance

The State of Nevada Department of Business and Industry, Division of Insurance ("Division"), (775) 687-0700, will hold a public hearing at **9:00 a.m., on August 10, 2012,** at the Division's office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706. Interested persons may also participate through a simultaneous videoconference conducted at the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of the regulation(s) that pertains to chapter 685A of the Nevada Administrative Code ("NAC").

The following information is provided pursuant to the requirements of Nevada Revised Statute ("NRS") 233B.0603 and the directives of the Governor:

LCB File No. R034-12. Nonadmitted Insurance.

A regulation relating to insurance; revising provisions relating to nonadmitted insurance; and providing other matters properly relating thereto.

- (1) Why is the regulation necessary and what is its purpose? The adoption of regulations is necessary to bring Nevada into compliance with new federal law and to clarify the intent of Chapter 685A of Nevada Revised Statute (NRS) as amended by Senate Bill 289.
- What are the terms or substance of the proposed regulation? The proposed regulation (2) amends Chapter 685A of the Nevada Administrative Code (NAC), the surplus lines chapter. The proposed regulation mirrors the requirements of the Nonadmitted and Reinsurance Reform Act (NRRA), part of the Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010 to bring Nevada into compliance with the new federal law. The intent of the NRRA is for each state to adopt nationwide uniform requirements in various areas of premium taxation and regulation of nonadmitted insurance. It also broadens the scope of this chapter to now be referred to as "nonadmitted insurance," encompassing both surplus lines insurance and independently procured insurance under the one term. The NRRA also states that only the home state, as defined in the federal law, may require a payment of premium tax for nonadmitted insurance, but does allow states to participate in a multi-state agreement or compact as a mechanism to share premium taxes. The proposed regulation allows the Commissioner to establish allocation formulas and filing procedures for use by surplus-lines brokers so that Nevada can collect multi-state premium tax if Nevada participates in a multistate agreement or compact.
- (3) What is the anticipated impact of the regulation on the problem(s)? The proposed regulation brings Nevada into compliance with the NRRA. If not adopted, Nevada would face the consequences of not complying with federal law. Also, the Nevada Administrative Code would be in direct conflict with the Nevada Revised Statutes and not able to provide guidance

on the intent of the statute.

- (6) What value does the regulation have to the public? The proposed regulation facilitates uniformity in reporting of policies and payment of premium tax in the nonadmitted market.

- (10) Does the regulation establish a new fee or increase an existing fee? The proposed regulation does not establish a new fee or increase an existing fee that would be payable to the Division or the State. However, the Commissioner entered the Nonadmitted Insurance Multi-State Agreement (NIMA) on July 20, 2011, as a multi-state tax-sharing mechanism. If NIMA becomes operational, surplus-lines brokers may be required to pay an additional fee to the NIMA clearinghouse which is a national clearinghouse.
- (11) Provide a statement which identifies the methods used by the agency in determining the impact of the proposed regulation on a small business, prepared pursuant to subsection 3 of NRS 233B.0608. Nonadmitted insurance usually covers hard-to-place risks such as a distressed business with a high frequency of prior losses or a unique exposure such as insurance for an explosive distributor, which could apply to a small business. This is evidenced by reports generated within the Nevada Surplus Lines Association regarding risks written in the nonadmitted market. The Division of Insurance is also able to access and view this information.
- (12) Provide a description of any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates, and a statement explaining why the duplication or overlapping is necessary.
