**NOTICE OF INTENT TO ACT UPON REGULATION
RE: R053-12**

**Notice of Hearing for the Adoption, Amendment or Repeal of Regulations of
The Department of Business and Industry, Division of Insurance**

The State of Nevada Department of Business and Industry, Division of Insurance (“Division”), (775) 687-0700, previously provided notice regarding a public hearing scheduled to occur at **1:30 p.m., on September 26, 2012**, at the Division’s office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706, with videoconferencing to the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The intended purpose of the scheduled hearing was to receive comments from all interested persons regarding the adoption, amendment or repeal of the regulation(s) that pertains to **chapter(s) 616A and 683A** of the Nevada Administrative Code (“NAC”), concerning the following:

LCB File No. R053-12. External Reviews and Reapproval Period/Fees.

A regulation relating to insurance; amending provisions relating to the external reviews of adverse determinations of certain health carriers; increasing the fee for reapproval of an independent review organization to conduct external reviews of adverse determinations; and providing other matters properly relating thereto.

At a Workshop held on September 17, 2012, at the Division’s office located at 1818 East College Parkway, Carson City, Nevada 89706, with videoconferencing to the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104, it was determined by the Hearing Officer that proposed changes to the regulation, LCB File No. R053-12, are substantive and will require additional review by the Legislative Counsel Bureau (“LCB”). The Hearing Officer, therefore, cancelled the Hearing scheduled for September 26, 2012 in order to schedule another workshop and hearing subsequent to LCB’s re-review. The subsequent workshop and hearing will be properly noticed again pursuant to chapter 233B of NRS.
